INDEPENDENT COMMUNICATIONS AUTHORITY OF SOUTH AFRICA**NOTICE 702 OF 2018****RENEWAL OF CLASS ELECTRONIC COMMUNICATIONS SERVICE AND
CLASS ELECTRONIC COMMUNICATIONS NETWORK SERVICE LICENCES**

1. The Independent Communications Authority of South Africa ("the Authority") hereby issues a notice to remind Class Electronic Communications Service (C-ECS) and Class Electronic Communications Network Service (C-ECNS) Licensees whose licences are due to expire to submit their licence renewal applications.
2. Section 19(2) of the Electronic Communications Act 36 of 2005 (ECA), as amended provides that Class licensees seeking to renew their class licences must, in writing and no less than six (6) months prior to the expiration of their class licence, notify the Authority of the intention to continue to provide the services.
3. Regulation 9 (2) of the Licensing Processes and Procedures Regulations for Class licences of 2010, as amended, provides that a notice to renew a class licence must be submitted to the Authority no earlier than twelve (12) months and no later than six (6) months prior to the expiry of the licence.
4. The Authority reminds Licensees whose licences were issued during 2008 and 2009 to submit their licence renewal applications no earlier than twelve (12) months and no later than six (6) months prior to the expiry of the licence.

5. The Licensing Processes and Procedures Regulations for Class licences of 2010 (Government Gazette No. 33297 of 14 June 2010), including amendments thereto (Government Gazette No. 39874 of 30 March 2016) are available on ICASA's website (www.icasa.org.za). Licensees are specifically directed to the requirements of regulation 9 (1) to (4) of the aforementioned Regulations when preparing and submitting their renewal notices.
