Kindly take notice that the Code of Conduct as published by the National Forum on 10 February 2017 (GG 40610) is hereby suspended by the Legal Practice Council (LPC).

The LPC is embarking on a process of developing the code of conduct in terms of section 36 of the LPA. Before the Code of Conduct becomes operational and effective the LPC will publish the draft thereof for comments by interested persons.

In the meantime, the legal profession will be regulated by the Rules referred to under section 95 (1), (3) and 97(2)(c) of the Legal Practice Act (the Act) as published by the National Forum in terms of section 109 (2) and (3) of the Act, gazetted on 20 July 2018 (GG 41781) and all the rules referred to under section 119 (2) of the LPA.
