AMENDMENT TO RULE 10(5) OF THE RULES FOR THE CONDUCT OF PROCEEDINGS IN THE COMPETITION COMMISSION

I, Ebrahim Patel, Minister of Economic Development, hereby publish in terms of section 21(4) of the Competition Act, 1998 (Act No. 89 of 1998), the final amendment to Regulation 10(5) of the Competition Commission Rules.

The new filing fees for intermediate and large mergers shall be effective from 1 January 2019.

- (a) R165 000.00 (one hundred sixty five thousand Rand) for an intermediate merger; or
