I, Grace Naledi Mandisa Pandor, Minister of Higher Education and Training, in terms of Section 3(3) and (4) of the *Continuing Education and Training Act, 2006, (Act No.16 of 2006)*, hereby publish the conditions for disposal and alienation of movable assets by Technical and Vocational Education and Training (TVET) Colleges acquired with the financial assistance of the state.

The publication is to grant approval for the TVET College Councils to dispose of or alienate movable assets acquired with the financial assistance of the state, with the initial acquisition cost of R280 000.00 or lower per item without the concurrence of the Minister.

TVET Colleges may write off and dispose of movable assets throughout the financial year at various intervals, depending on when the movable assets have reached the end of their respective useful lifespans.

TVET Colleges that want to write off movable assets with an initial acquisition cost higher than R280 0000.00 and any immovable assets must still obtain concurrence of the Minister as required by the CET Act.

The notice is effective from the date of publication and must be applied progressively.

Amendment of the minimum admission requirements for entry into Bachelor's Degree programmes for holders of the National Senior Certificate

The Schedule to Government Notice 751 published in Gazette 31231 of 11 July 2008 is amended as set out below.

The portion of Paragraph 4 on pages 8 and 9 under the heading "**Bachelor's Degree**" is deleted and is replaced by the following:

"Bachelor's Degree"

The minimum admission requirement is a National Senior Certificate (NSC) with a minimum of 30% in the language of learning and teaching of the higher education institution as certified by Umalusi, coupled with an achievement rating of 4 (Adequate Achievement, 50 – 59%) or better in four 20-credit NSC subjects.

A 20-credit NSC subject is a subject recognised for the seven-subject NSC package as approved by the Minister of Basic Education in terms of the National Education Policy Act, 1996 (Act No. 27 of 1996).

Adequate Achievement in the NSC and in at least four 20-credit NSC subjects provides the primary basis for admission to a Bachelor's Degree programme. An institution is entitled to specify an appropriate level of subject achievement for a particular programme. For example, admission requirements for a Bachelor's Degree programme in Fine Art or Music might include a specified level of achievement in the corresponding recognised NSC subject/s. Similarly, an institution will be entitled to specify subject requirements for a particular programme. For example, Mathematics and Physical Science might be considered as requirements for admission to a Bachelor of Science Degree.



In accordance with the provisions of Section 53.1 of the Anti-Dumping Regulations of the International Trade Administration Commission of South Africa (ADR), any definitive anti-dumping duty shall be terminated on a date not later than five years from the date of imposition, unless the authorities determine, in a review initiated before that date on their own initiative or upon a duly substantiated request made by or on behalf of the domestic industry within a reasonable period of time prior to that date, that the expiry of the duty would be likely to lead to continuation or recurrence of dumping and material injury.

On 21 July 2018 the International Trade Administration Commission (the Commission) notified the SACU Industry, through Notice No. 546 of 2017 in Government Gazette No. 40998, that unless a substantiated request is made by the SACU industry indicating that the expiry of the anti-dumping duties on the subject product originating in or imported from the People’s Republic of China (the PRC) and Chinese Taipei would likely lead to the continuation or recurrence of dumping and material injury. The relevant anti-dumping duties on the subject product originating in or imported from the PRC and Chinese Taipei will expire on 09 May 2018.

The sunset review investigation was initiated pursuant to Notice No. 41598 dated 26 April 2018. Questionnaires were sent to interested parties on 02 May 2018. The due date for responses was 08 June 2018. No responses were received by the Commission from any manufacturer/exporter of the subject product in the PRC and Chinese Taipei and importer of the subject product in the SACU.

After considering the information submitted before it, the Commission issued essential facts letters indicating that it was considering making a final determination that the expiry of the anti-dumping duties on the subject product originating in or imported from the PRC and Chinese Taipei would lead to the recurrence of dumping and material injury.

After considering the comments received from the Applicant to the Commission's essential facts letter, the Commission made a final determination that the expiry of the anti-dumping duties on the subject product originating in or imported from the PRC and Chinese Taipei would lead to the recurrence of dumping and material injury.



**AMENDMENT OF THE DIRECTIVE FOR CONDUCT WITHIN THE NATIONAL PAYMENT
SYSTEM IN RESPECT OF THE COLLECTION OF PAYMENT INSTRUCTIONS FOR
AUTHENTICATED COLLECTIONS**

FIRST AMENDMENT OF DIRECTIVE NO. 1 OF 2017

1. Legal Framework and Background

- 1.1. In terms of section 10 (1) (c)(i) of the South African Reserve Bank Act, 1989 (Act No. 90 of 1989) (the SARB Act), the South African Reserve Bank (the SARB) is required to perform such functions, implement such rules and procedures and, in general, take such steps as may be necessary to establish, conduct, monitor, regulate and supervise payment, clearing or settlement systems. Furthermore, the National Payment System Act, 1998 (Act No. 78 of 1998) (the NPS Act) provides for the management, administration, operation, regulation and supervision of payment, clearing and settlement systems in the Republic of South Africa, and for connected matters.
- 1.2. The National Payment System (NPS) encompasses the entire payment process from payer to beneficiary, and includes settlement between banks. The process includes all the tools, systems, instruments, mechanisms, institutions, agreements, procedures, rules or laws applied or utilised to effect payment. The NPS is a primary component of the country's monetary and financial system as it enables the circulation of money, assisting transacting parties to make payments and exchange value.
- 1.3. In terms of section 12 (1) of the NPS Act, the SARB may from time to time, after consultation with the payment system management body, issue directives to any person regarding a payment system or the application of the provisions of the NPS Act.
- 1.4. The Directive for Conduct within the National Payment System No. 2 of 2006 published in the Government Gazette No. 28867, General Notice 680 of 2006 (Directive No. 2 of 2006) regulated the Early Debit Order (EDO) systems since 2006.

- 1.5. An in-depth investigation into the EDO environment, prompted by inefficiencies in the EDO systems, identified various issues, in both the Authenticated Early Debit Order (AEDO) and the Non-Authenticated Early Debit Order (NAEDO) systems. These issues spread across the payment system value chain from the customer who authorises the debit (payer) through to the collector (user), system operators, sponsoring and acquiring banks.
- 1.6. The issues included, amongst others, the growing number of disputes by payers relating to unauthorised debits and user complaints of illegitimate payer initiated reversals. A key concern for the SARB is the growing mistrust in the EDO systems and increasing complaints of abuse. These trends indicated the underlying structural issues to be addressed.
- 1.7. This culminated in the issuance of a Terms of Reference (ToR) by the SARB in July 2013, entitled: "Collections Review: Terms of Reference for the Payments Association of South Africa". The ToR defined the scope and minimum requirements for the design, development and implementation of an appropriate approach to the EDO collections.
- 1.8. Following the issuance of the ToR, the 'Authenticated Collections (AC)', initiative was launched with the objective of creating a method of collection that protects both sides of the market (payers and users). The Payments Association of South Africa (PASA) in collaboration with the relevant stakeholders was tasked to develop new authentication options for early debit orders that should give payers the opportunity to authorise future dated debit order mandates through an authentication process.
- 1.9. Subsequent to broad consultation and engagement with industry, the SARB has deemed it necessary to amend the Directive No. 1 of 2017. This Directive amends and restates Directive No. 1 of 2017.

2. Objective and Purpose

- 2.1. The main objective of AC is to address the safety and efficiency of debit order collections, by strengthening debit order mandates through the ability of payers to upfront authenticate and authorise future dated debit orders, thereby attempting to protect both sides of the market.
- 2.2. This Directive provides for the conduct of participants involved in the collection of payment instructions in the early debit order environment.

3. Position of the SARB

- 3.1. The SARB supports AC and is issuing this Directive in respect of the establishment of an authenticated collections mechanism in the early debit order environment to address the risks associated with the level of unauthorised debits and dispute ratios to maintain a safe and efficient NPS.
- 3.2. The SARB acknowledges that payment systems that process debit order payment instructions in the early processing window, similar to the current early debit order collections environment, are required by participants of the NPS, and should provide for appropriate risk management.
- 3.3. All the NPS participants who participate in the EDO payment clearing houses (PCHs), namely AEDO and NAEDO PCHs are required to implement AC by 31 October 2019.

4. Interpretation and Definitions

In this Directive, unless the context indicates otherwise, the words and expressions used herein shall have the same meaning assigned to them in the NPS Act and related expressions shall have corresponding meanings. The additional definitions below are provided for clarity.

4.1. Authentication

Authentication is the electronic process whereby the payer, (i) confirms the prescribed elements of a debit order mandate; and (ii) authorises the paying bank to debit the

payer's account in accordance with the debit order mandate.

4.2. Authorisation

Authorisation refers to the consent given by the payer to the paying bank to honor a debit order when presented to the payers account in accordance with the authenticated debit order mandate.

4.3. Authenticated Collections (AC)

Debit order instructions which have been authorised by the payer and which are presented against the payer's account for collection in the early morning processing window through the AC PCH to be established under the EDO PCH PG.

4.4. Directive

Directive means Directive No. 1 of 2017 as amended and restated by this document.

4.5. Early processing window

Early processing window is the period or window where early morning collections are processed directly after bulk credits.

4.6. Implementation Date

Implementation Date means the implementation date for Authenticated Collections which is 31 October 2019.

4.7. Sunset Date

Sunset Date means the date on which the processing of AEDO and NAEDO payment instructions will be terminated which is 31 October 2020.

5. Directive

- 5.1. Participants involved in the collection of payment instructions in the EDO environment are directed to:
 - 5.1.1. design, develop and fully implement the payment system infrastructure to facilitate the collection of randomised early debit orders through AC in the early processing window, by the Implementation Date;
 - 5.1.2. maintain the stability of the existing systems and minimise operational risk throughout the migration period to full AC implementation;
 - 5.1.3. reach full implementation of AC through a phased approach and within the delivery dates prescribed in the SARB approved Implementation Plan referred to in 5.2 below;
 - 5.1.4. report progress on implementation of AC as and when requested by SARB in terms of section 10 of the NPS Act;
 - 5.1.5. comply with the applicable regulatory requirements, including the rules, compliance and enforcement framework set by PASA in respect of AC;
 - 5.1.6. subject to 5.1.8, continue to process AEDO and NAEDO payment instructions where the contractual term exceeds the Implementation Date until the Sunset Date. These contracts shall be migrated to AC on or before the Sunset Date;
 - 5.1.7. not allow any new, extended or re-negotiated AEDO or NAEDO collection agreements to be concluded from 1 May 2020;
 - 5.1.8. from 1 November 2019 until the Sunset Date, proceed to process AEDO and NAEDO payment instructions in the early window subject to AC debit orders and AEDO payment instructions being given priority over NAEDO payment instructions; and
 - 5.1.9. phase-out AEDO and NAEDO payment instructions from 1 May 2020 until the Sunset Date.
- 5.2. PASA, supported by all industry participants must prepare the AC implementation

plan (Implementation Plan) with phases and timelines for approval by the SARB, monitor compliance with the Implementation Plan by the participants and take appropriate (and where required) maximum enforcement action through an appropriate compliance and enforcement framework. Such compliance framework must include an escalating mechanism for each milestone missed.

- 5.3. PASA, supported by all industry participants must continue to improve the safety and efficiency of debit orders, including the introduction of measures to address risk emanating from debit order abuse.
- 5.4. PASA must make provision for AC, including the participation criteria, in the relevant PASA regulatory framework and rules.

6. Conclusion

- 6.1. This Directive is not exhaustive and may be supplemented or amended from time to time.
- 6.2. In order to maintain the effectiveness, efficiency and neutrality of the NPS, all participants in the NPS that are, or become involved in the EDO PCH PG as indicated herein are obliged to act in accordance with the NPS Act and in particular, this Directive.
- 6.3. This Directive is effective from the date of publication thereof in the Government Gazette (Effective Date).
- 6.4. Contravention of this Directive is an offence in terms of section 12 of the NPS Act. Any person convicted of an offence in terms of this Directive is liable to a fine or imprisonment or to both a fine and such imprisonment.
- 6.5. Persons who are uncertain as to whether their current or future business practices are aligned with this Directive should initiate discussions with PASA or the NPS Department of the SARB to clarify the matter.

7. Repeal of Directive No. 2 of 2006

- 7.1. Directive No. 2 of 2006 is repealed with effect from the date of publication of Directive No. 1 of 2017.

BOARD NOTICE 182 OF 2018**NATIONAL COUNCIL OF SOCIETIES
FOR THE PREVENTION OF CRUELTY
TO ANIMALS****R U L E S****1 NEW RULE TO BE NUMBERED 2.18**

In the event that complaints are made against Inspectors or Field Officers:

- (a) The complaint shall be submitted in writing, in the form of an affidavit, and addressed to the Chief Executive Officer of the National Council of SPCA's ("the CEO");
- (b) Upon receipt of a complaint, the CEO shall notify the person against whom the complaint is made ("the Respondent"), and attach a copy of the complaint to the notification. In the notification, the CEO shall advise the Respondent that:
 - (i) he/she may furnish an explanation, in the form of an affidavit, before a stipulated date no later than 21 days of the date of the notification, or by such further date as may be agreed;
 - (ii) such an explanation may be used in evidence against him/her;
 - (iii) he/she has the right to refuse to answer any allegations that might incriminate him/her; and
 - (iv) he/she is entitled to seek legal representation prior to providing such an affidavit.
- (c) The Respondent's affidavit, together with the complaint, shall be submitted to an investigation committee appointed by the Board. If no affidavit is received, the CEO shall forward the complaint to the investigation committee at the expiry of the 21-day period, or such further period as may have been agreed.
- (d) The investigation committee shall conduct an investigation into the allegations and shall compile a report of their findings, which shall be submitted to the CEO.
- (e) If the investigation committee resolves that a complaint does not constitute unprofessional, illegal or unethical conduct, the CEO shall provide a copy of the report to the complainant. In the event that the complainant is not satisfied with this decision, then the evidence and report shall be referred to the Board for a decision as to whether an inquiry into the conduct in question should be held.
- (f) If it appears to the investigation committee or the Board that an inquiry should be held into the conduct of the Respondent, it shall direct the CEO to convene such an enquiry. The CEO shall provide the Respondent with written notice of such an enquiry, stating where and when the enquiry into his/her professional conduct will be held, and enclosing a charge sheet which shall clearly set out the charges that are to be addressed at the enquiry.
- (g) Notice shall be served on the Respondent by the Sheriff of the Court or by hand, and proof of delivery shall be provided to the CEO.
- (h) The enquiry shall be conducted on the same terms as a disciplinary enquiry as set out in the Operations Manual.
- (i) The chairman of the enquiry shall be entitled in the event that the Respondent's conduct contributed to the suffering of an animal or compromised its welfare, to suspend, for such period as he/she deems fit, or to cancel the Respondent's Letters of Authorisation.
- (j) The CEO shall advise the governing body and the manager of the Society by whom the Respondent is employed of the decision of the Chairman, and the Society shall ensure that the decision is enforced.

- (k) The Society shall further be obliged to notify the Chief Magistrate of the areas for which the Respondent hold Letters of Authority of the decision, and to return the Letters of Authority to the Chief Magistrate(s) for cancellation.

2 NEW RULE TO BE NUMBERED 2.19

An Inspector or Field Officer is obliged to report any unprofessional, illegal or unethical conduct by another Inspector or Field Officer particularly where an animal's welfare has been or may be compromised.

3 AMMEND RULE 5.4

(a) All cruelty complaints, complaints against a society, its employees or committee members, shall be investigated, (including those reported anonymously), within 24 hours or within reason, unless immediate attention to the animal(s) is required.

(b) The findings of such investigations shall be reported to the complainant, if known, in the most appropriate manner within seven (7) days of the complaint being lodged.

(c) All investigations should be documented. Warnings shall be in writing and all investigations shall be followed up to prevent suffering.

(d) When an SPCA receives a complaint which does not fall in their jurisdiction, they follow it all the way through until the complaint is resolved. The onus must rest on the reporting SPCA to ensure that the complaint is attended to and appropriate action taken.

4 NEW RULE TO BE NUMBERED 2.20

Vehicles and trailers owned by the Society must be registered in the name of the Society. No vehicle or trailer owned by the Society may be registered in the name of any person, with exception of the proxy of the vehicle being in the name of the Manager or Chairperson.

5 AMEND RULE 2.17

A Society shall ensure that all staff and committee / board members produce a Police Clearance Certificate issued by the South African Police Services within 3 months of becoming a committee / board member of employee. This applies to current and prospective employees, and committee members / directors. It also applies to volunteers who are dealing with Society funds unsupervised.

1 NEW CLAUSE NUMBER 16

No director or committee member shall be answerable for, or liable to make good any loss occasioned or sustained by any cause, howsoever arising, save and except such loss as shall arise from or be occasioned by his/her own personal and wilful dishonesty. No director or committee member shall be liable for any act of dishonesty committed by another director or committee member unless he/she was privy thereto. The directors or committee members shall be indemnified by the Society against all claims and demands of whatsoever nature that may be made upon them arising out of the exercise or purported exercise of any of the powers conferred upon them by the Constitution.
