**Amendments to the terms of reference of the Inquiry in terms of section 32 of the National Prosecuting Act 38 of 1998, into the fitness of Advocate Nomgcobo Jiba and Advocate Lawrence Sithembiso Mrwebi to hold office of Deputy National Director of Public Prosecutions and Special Director of Public Prosecutions respectively**

WHEREAS I have, in terms of Notice No. 699 of 2018 published in the Government Gazette No. 42029 of 9 November 2018 published the terms of reference of the Inquiry into the fitness of Advocate Nomgcobo Jiba and Advocate Lawrence Sithembiso Mrwebi to hold office of Deputy National Director of Public Prosecutions and Special Director of Public Prosecutions respectively instituted in terms of section 12(6) of the National Prosecuting Act, 1998 (Act No. 38 of 1998);
