BROADCASTING SERVICE AND RADIO FREQUENCY SPECTRUM LICENCES**

1. The Independent Communications Authority of South Africa ("the Authority") hereby gives notice that it has received three applications to renew Individual Commercial Sound Broadcasting Services and Radio Frequency Spectrum Licences lodged in terms of Regulation 10 of the Processes and Procedures Regulations for Individual Licences and Special Temporary Authorisations of 2010 together with Amendment Individual Processes and Procedures Regulations 2015 read together with section 11 of the Electronic Communications Act No. 36 of 2005 ("EC Act"). In terms of section 11(3) read with section 9(2)(a) of the EC Act, the Authority is required to give notice of the application in the *Government Gazette* and invite interested persons to submit written representations in relation to the application.
2. The application, relevant schedule and any representations received pursuant thereto would be made available and be open for inspection by interested parties in the Authority's library during the Authority's normal office hours.
3. Interested parties are invited to lodge written representations in relation to the application within fourteen (14) working days from the date of publication of this notice in the *Government Gazette*. Persons who lodge representations must also indicate whether they wish to make oral submissions should the Authority decide to hold a public hearing in respect of the application.

4. All written representations, responses and other correspondence in terms hereof must be directed to Mr Thabo Ndhlovu in the Broadcasting Service Licensing Unit, Licensing Division both at Block B, Eco Point Office Park, 350 Witch-Hazel Avenue, Centurion, Pretoria **OR** by fax no. 5. Persons who submit representations in terms of this notice shall, when submitting such representations, provide proof to the satisfaction of the Authority that a copy of the representations submitted has been sent by registered mail or by facsimile, or delivered to the persons mentioned in the schedule below.

6. All Applicants shall be entitled to respond in writing to written representations made by interested persons on the renewal applications, and such written responses must be lodged with the Authority within twenty-one (21) working days from the date of publication of this notice in the *Government Gazette*. Applicants must, at the time of lodging such written responses, furnish proof to the Authority's satisfaction that it has delivered a copy of such response by hand, or has sent a copy of such response by registered mail or by email to the relevant person having made such written representations.
