Notice is hereby given in terms of Regulation 3 and 4 of the Regulations made under section 109 (1) (a) of the Legal Practice Act No.28 of 2014 and Rule 16 (9) of amended Rule 16 (as gazetted on 21 December 2018 (Gazette no 42127)), to every practising attorney and advocate, calling for nominations of practising attorneys and advocates for the elections to the Provincial Councils. Each attorney must nominate only an attorney and each advocate must only nominate any advocate.
