Notice is hereby given in terms of Section 49(1)(a)(i) read together with Section 78(2) of the Local Government Municipal Property Rates Act, 2004 (Act No. 6 of 2004), herein referred to as the "Act", that the General Valuation Roll for the financial years 2019/2020 to 2022/2023 is open for public inspection at the Ulundi Local Municipality offices, Ulundi Library or at website http://www.ulundi.gov.za from 21 February 2019 to 26 March 2019. An invitation is hereby made in terms of Section 49(1)(a)(i) of the Act that any owner of property or other person who so desires should lodge an objection with the Municipal Manager in respect of any matter reflected in, or omitted from, the Property Valuation Roll.

Attention is specifically drawn to the fact that an objection is to a specific individual property and not against the Property Valuation Roll as such. The form for lodging an objection is obtainable at the Municipal offices in Ulundi. The completed objection forms must be returned **by hand** to the Municipal Offices where account is held, BA 131 corner Princess Magogo and King Zwelithini Street, Ulundi, during office hours 07h30 to 16h30 Monday to Thursday and 07h30 to 15h15 on Fridays. **Closing date for Objections is 16h30 on Tuesday 26 March 2019**. **No late objections will be accepted**.
