### DETERMINATION AND IMPLEMENTATION OF THE CURRICULA FOR TRAFFIC OFFICERS

I, Dr B.E Nzimande, Minister of Transport do hereby substitute Notice number 1184 published on 29 October 2018 under Government *Gazette* 42004 with this notice.

I hereby determine and implement in terms of section 75 of the National Road Traffic Act, 1996 (Act No.93 of 1996), read together with regulation 2B(3) of the National Road Traffic Regulations, 2000 curriculum for traffic officers approved by the Quality Council for Trades and Occupations and registered by the South African Qualifications Authority under registration: South African Qualification Identity number, 97639 with effect from 1 November 2018: Provided that any traffic officer's qualification obtained from a Training Centre referred to in section 3D (1) (a) of the National Road Traffic Act, 1996 (Act No. 93 of 1996) prior to 1 April 2022 shall be recognised.
