**FINANCIAL SECTOR REGULATION ACT, 2017: AMENDMENT OF NOTICE OF COMMENCEMENT**

In terms of section 305 of the Financial Sector Regulation Act, 2017 (Act No. 9 of 2017) ("the FSRA"), I, Tito Titus Mboweni, Minister of Finance hereby amend General Notice 142 of 18 March 2019, as corrected by Government Notice 657 of 10 May 2019, by the substitution for paragraph (b) of the following paragraph:

- "(b) amend Government Notice 1019 of 28 September 2018, by the substitution in—
- (i) paragraph (a)(v) for the expression '1 September 2019' of the expression '1 October 2020';
  - (ii) paragraph (b) for the expression '1 September 2019' of the expression '1 April 2020';".
