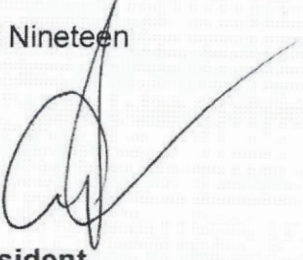

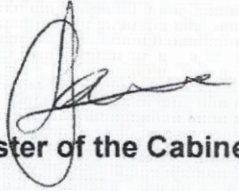
**AMENDMENTS TO THE TERMS OF REFERENCE OF THE A COMMISSION OF
INQUIRY INTO ALLEGATIONS OF IMPROPRIETY REGARDING THE PUBLIC
INVESTMENT CORPORATION**

Under the powers vested in me by section 1 of the Commissions Act, 1947 (Act No. 8 of 1947) I hereby, with effect from 31 October 2019, amend the Terms of Reference of the Commission of Inquiry into allegations of impropriety regarding the Public Investment Corporation (PIC) published under Proclamation No.30 of 2018 in the Government Gazette No. 41979 of 17 October 2018 as indicated in the attached Schedule.

Definition

1. In this Proclamation "Terms of Reference" means the terms of reference published under Proclamation No. 30 of 2018 in the Government Gazette No. 41979 of 17 October 2018 as amended by Proclamations No. 21 of 2019 and No. 47 of 2019 respectively.

Amendment of the Terms of Reference

2. Paragraph 3.2 of the Terms of Reference is hereby amended as indicated below:
 - “3. The Commission must submit-
 - 3.1. an interim report to the President by not later than 15 February 2019;
and
 - 3.2. a final report by not later than **[31 October 2019]** 15 December 2019.”
4. The amendments to the Terms of Reference published under this Proclamation shall come into effect on 31 October 2019.
