CANCELLATION OF REGISTRATION OF A TRADE UNION

I, **Mary Mongwadi Ngwetjana**, Deputy Registrar of Labour Relations, hereby, in terms of section 109(2) read with section 106(2A), cancel the registration of **Democratic Municipal and Allied Workers Union of South Africa (DEMAWUSA) (LR 2/6/2/2420)** with effect from 30 January 2020

The registration of the trade union is cancelled due to the following reasons:

- The trade union failed to comply with sections 99 and 100 of the Act
- The Union failed to comply with Guidelines for balloting regarding members having a secret ballot before embarking on a strike action.

The name of the Organisation has been removed from the Register of Trade Unions.
