FINANCIAL SECTOR REGULATION ACT, 2017: AMENDMENT OF NOTICE OF COMMENCEMENT

In terms of section 305 of the Financial Sector Regulation Act, 2017 (Act No. 9 of 2017) ("the FSRA"), I, Tito Titus Mboweni, Minister of Finance hereby amend—.
