**Point to point description of the road proclamation over the remainder of portion 6 of the farm Daggafontein 125 IR:**

The portion of the Jan Smuts road to be proclaimed over the remainder of portion 6 of the farm Daggafontein 125 IR is of uneven width and described by the letters A, B, C, D, E, F, G, H, J, K, A on diagram SG No. 5790/2016. The road runs parallel and about 450 m north of the existing N17 highway.

**Point to point description of the road proclamation over the remainder of portion 158 of the farm Daggafontein 125 IR:**

The portion of the Jan Smuts Road to be proclaimed over the remainder of portion 158 of the farm Daggafontein 125 IR is of even width and described in the letters A, B, C, D, A on the diagram SG No. 5791/2016. The road runs parallel and about 450 m north of the existing N17 highway.
