THE NOTICE ISSUED BY THE DIRECTOR-GENERAL UNDER COMPENSATION FOR OCCUPATIONAL INJURIES AND DISEASES ACT, 1993

I, Thobile Lamati, The Director General of Employment and Labour, hereby in terms of S83 (1); S85 (1) and S78 of the Compensation for Occupational Injuries and Diseases Act, 1993 (Act No 130 of 1993) as amended issue the following Notice:

- a) An increase of the Minimum Assessment to R1284 in terms of S83 (1)
- b) The withdrawal of the implementation of S85 (1) on reductions with effect 1 March 2021 until further notice.
- c) The withdrawal of the implementation of the S78 with effect 1 March 2021 until further notice.
