

AN ADJUSTMENT TO THE MASS SPECIFICATION OF THE FINE-SILVER 20Z KRUGERRAND

The fine-silver 2oz Krugerrand was published in the Government Gazette on the 11th of October 2019, and issued for the first time in 2020.

The 'Mass' specification has been adjusted and updated in Schedule 2 of the South African Reserve Bank Act (Act No. 90 of 1989). The adjusted specification is featured below.

A CORRECTION TO THE DIAMETER SPECIFICATION OF THE STERLING-SILVER 2 1/2 C TICKEY IN SCHEDULE 2 OF THE SOUTH AFRICAN RESERVE BANK ACT (ACT NO. 90 OF 1989)

The 'Diameter' specification of the sterling-silver 2 1/2 c Tickey was incorrectly recorded as 15.30mm instead of 16.30mm. The specification has been corrected and updated in Schedule 2 of the South African Reserve Bank Act (Act No. 90 of 1989).
