**SOUTH AFRICAN RESERVE BANK****NOTICE 550 OF 2021****Invitation to make representations in respect of the potential forfeiture of money in terms of Regulation 22B of the Exchange Control Regulations, 1961**

Alleged contraventions of the provisions of the Exchange Control Regulations, made under section 9 of the Currency and Exchanges Act, 1933 (Act No. 9 of 1933) as amended, as promulgated by Government Notice R.1111 of 1961-12-01 as amended

**To:** The Respondents listed in Annexure A hereto

**Be pleased to take notice that:**

1. The Minister of Finance of the Republic of South Africa (the Republic) has, by virtue of the provisions of Exchange Control Regulation 22E made under section 9 of the Currency and Exchanges Act, 1933 (Act No. 9 of 1933), as amended, as promulgated by Government Notice R.1111 of 1961-12-01, as amended from time to time thereafter, delegated the powers and/or functions conferred upon the Treasury by the provisions of the Exchange Control Regulations (with the exception of the powers and functions conferred upon the Treasury by Exchange Control Regulations 3(5), 3(8), 20 and 22 which exception does, however, not include Exchange Control Regulations 22A, 22B, 22C and 22D) and assigned the duties imposed thereunder on the Treasury, to the Governor and Deputy Governors of the South African Reserve Bank (SARB).
2. Investigations conducted by the Financial Surveillance Department (FinSurv) of the SARB indicate that, during or about the period December 2017 to November 2018, the Respondents were party to certain acts and/or omissions which constituted contraventions of the Exchange Control Regulations or which are, on reasonable grounds, suspected to have constituted such contraventions, details of which contraventions or suspected contraventions are more fully set out in paragraph 4 below.
3. Pursuant to the above, a duly authorised officer of FinSurv issued various orders, during or about the period 2018-11-09 to 2018-11-22, in terms of the provisions of Exchange Control Regulation 22A and/or 22C, whereby no person may withdraw, or cause the withdrawal of, or appropriate in any manner certain funds standing to the credit of the respective Respondents in accounts held at FirstRand Bank Limited. Details of the amounts and account numbers for the respective Respondents are reflected in Annexure A hereto.
4. As referred to in paragraph 2 above, the following contraventions of the provisions of the Exchange Control Regulations have, inter alia, been committed or are, on reasonable grounds, suspected to have been committed, namely:
  - 4.1 contraventions or suspected contraventions of Exchange Control Regulation 10(1)(c) in that transactions, whereby capital or any right to capital was directly or indirectly exported from the Republic, were entered into, without permission granted by the Treasury or not in accordance with the conditions that the Treasury may have imposed; and/or
  - 4.2 contraventions or suspected contraventions of Exchange Control Regulation 19 read with Exchange Control Regulation 22 in that false and/or incorrect statements were made in declarations for the purposes of the Exchange Control Regulations. AKH

5. The money referred to in paragraph 3 above, is money which may be forfeited to the State in terms of Exchange Control Regulation 22B.
6. The purpose of this notice is, therefore, in compliance with the audi alteram partem principle, to invite the Respondents, which I hereby do, to make written representations for consideration by the appropriate designated functionary as contemplated in paragraph 1 hereof:
  - 6.1 in connection with the possibility that some or all of the money as described in paragraph 3 above, may be forfeited to the State in the manner provided for in Exchange Control Regulation 22B; and/or
  - 6.2 as to why some or all the money described in paragraph 3 above, should not be forfeited to the State in the manner as provided for in Exchange Control Regulation 22B.
7. The representations referred to in paragraph 6 above:
  - 7.1 may be made by the Respondents or on their behalf, with or without the assistance of a legal advisor;
  - 7.2 must be in writing and signed by the Respondents or on their behalf; and
  - 7.3 must on/or before 2021-10-04, reach FinSurv at 370 Helen Joseph Street (previously Church Street), Pretoria, 0002 or via email to SARBFNSDEPT@resbank.co.za for the attention of the Compliance and Enforcement Division under reference 201811-0017.
8. Should the Respondents for any valid reason be unable to respond hereto, or require any further information, elucidation or guidance in regard to the contents of this notice, they may, before 2021-09-27, submit full particularity as to the reason(s) for being unable to do so and/or make a request for assistance, guidance or elucidation, as the case may be, in writing for the attention of the Compliance and Enforcement Division under the above-mentioned reference number by email to SARBFNSDEPT@resbank.co.za.
9. The contents of this notice should not be construed as an admission of any allegation or fact relevant to this matter and is directed to the Respondents strictly without prejudice to any rights that this Department may have including the right to amplify the ambit of this letter should it become necessary.
10. Should this Department not receive representations as called for hereinbefore, it will proceed with the forfeiture process in terms of the provisions of Exchange Control Regulation 22B, without further notice.
