**DIRECTIONS ISSUED IN TERMS OF REGULATION 4(10) OF THE REGULATIONS MADE UNDER SECTION 27(2) OF THE DISASTER MANAGEMENT ACT, 2002 (ACT NO. 57 OF 2002): MEASURES TO PREVENT AND COMBAT THE SPREAD OF COVID-19**

I, **Ms Lindiwe Zulu, MP**, the Minister of Social Development, in terms of regulation 4 (10) of the Regulations made in terms of section 27(2) of the Disaster Management Act, 2002 (Act No. 57 of 2002), and published in Government Gazette No43258, Government Notice No. 480 of 29 April 2020 as amended, hereby issue Directions, as set out in the Schedule.

## Schedule

### 1. Definitions

In these Directions, unless the context indicates otherwise, the word-  
“**Directions**” means Directions issued in Government Notice No. 681 published  
in Government Gazette No. 44938 of 3 August 2021.

### Amendment of Direction 3 of the Directions

2. Direction 3 of the Directions is hereby amended by-  
the addition after subparagraph (3)(i) of the following subparagraph:  
“(j) a caregiver without a valid 13-digit identity number and who possesses a  
system generated number provided by SASSA”.

### Insertion of Direction 6A

3. The Directions are hereby amended by-  
the insertion of following Direction after Direction 6:  
“**6A.** A caregiver without a valid 13-digit identity number and who  
possesses a system generated number provided by SASSA and whose  
application for the Social Relief of Distress Grant is lodged during the  
months of September and October 2021 and approved, will be paid  
retrospectively from the month of August 2021 as if the grant application  
had been approved in the month of August 2021.”.

### Amendment of Direction 11 of the Directions

4. Direction 11 of the Directions is hereby amended by-  
the substitution for paragraph (c) of the following:  
“(c) payments not withdrawn by a beneficiary by 30 November 2021, will be  
forfeited to the State;”

### 5. Commencement

These Directions come into effect on the date of publication in the Government  
Gazette.
