**Amendment of Rule 22.1.4.2**

22.1.4.2 Council may, on the application of a candidate attorney in any case –

22.1.4.2.1 where the principal refuses to grant the candidate attorney leave of absence from office; or

22.1.4.2.2 where the period of absence from office exceeds, or the periods of absence from the office in the aggregate exceed, thirty working days in any one year of the practical vocational training contract authorize leave of absence from office for the period in question, if Council is satisfied that the principal and the Council received due notice of the application and that sufficient cause for the absence exists or existed, as the case may be.

**SCHEDULE****DEFINING OF PRODUCTION AREA: LOWER DUIVENHOKS RIVER**

That portion of land situates within the following boundaries:

Start at a point where the south-western boundary of Duivenhoks River Mouth 505 joins the ocean; thence generally north with the south-western boundary of said Duivenhoks River Mouth 505 and an imaginary straight line, drawn from the south-western beacon of said Duivenhoks River Mouth 505 to where it joins the farm road; thence further north with said farm road and other roads to the south-western beacon of Wagendrift 315/16; thence north-east with the western boundary of said Wagendrift 315/16 to the northern beacon thereof; thence further north-east with an imaginary straight line to a point where the road intersects the Duivenhoks River; thence generally east with an imaginary straight line, drawn from said river to a point where it joins the farm road; thence further east with said farm road to a point where it intersects the north-western boundary of De Nieuwe Put 394/1; thence north-east with the road, a portion of the north-eastern boundary of Wagendrift 315 and the north-western boundary of said De Nieuwe Put 394/1 to the northern beacon thereof; thence generally

south with the western boundary of De Nieuwe Put 394, the northern boundaries of Rietheuvel 400 and De Nieuwe Put 399/2 and an imaginary straight line which is an extension of the northern boundary of said De Nieuwe Put 399/2 to where it joins the farm road; thence generally south with the road to a point where the road intersects the eastern boundary of Kleinfontein 503/13; thence south-west with the eastern boundary of said Kleinfontein 503/13 to where it joins the ocean; thence north-west with the coastline to a point where the south-western boundary of Duivenhoks River Mouth 505 joins the ocean; the point of beginning mentioned above.
