

Definition

1. In this Proclamation "Terms of Reference" means the terms of reference under Notice No. 491 of 2021 as published in the Government Gazette No. 44688 of 10 June 2021.

2. The Terms of Reference is hereby amended by the substitution of paragraph five (5) for the following paragraph"

"5. The Commission shall submit its Interim Report on or before **[15 October 2021]** 15 April 2022 and its final Report by **[31 December 2021]** 30 July 2022."
