

AN EXTENSION OF COMMENT PERIOD FOR THE REGULATIONS RELATING TO SURVEILLANCE AND THE CONTROL OF NOTIFIABLE MEDICAL CONDITIONS: AMENDMENT; REGULATIONS RELATING TO PUBLIC MEASURES IN POINTS OF ENTRY; REGULATIONS RELATING TO THE MANAGEMENT OF HUMAN REMAINS AND REGULATIONS RELATING TO ENVIRONMENTAL HEALTH

I, Dr M.J Phaahla, the Minister of Health, in terms of section 90(1)(a),(K),(j) and (w); section 68(1)(b); of the National Health Act, 2003 (Act No.61 of 2003), and section 3(2) of the International Health regulations Act, 1974 (Act No. 28 of 1974) hereby extend the comment period for Regulations Relating to the Surveillance and Control of Notifiable Medical Conditions: Amendment, Notice No. 1882; Regulations Relating to Public Measures in Points of Entry, Notice No. 1883; Regulations Relating to the Management of Human Remains, Notice No. 1884; and Regulations Relating to Environmental Health, Notice No. 1885, all published in government gazette no. 46048 of 15 March 2002 to 24 April 2022.
