(a) extend the current period of designation of the South African Petroleum Industry Association (SAPIA), as determined in Government Gazette No. 45691 of 21 December 2021, for a further three (3) months until 31 July 2022; and

(b) determine that this Notice shall be in force and effect as from 1 May 2022.
