The Head of the Department hereby, in terms of section 28(4) read with section 27(1) of The South African National Roads Agency Limited and National Roads Act, 1998 (Act No. 7 of 1998) [the Act], makes known in terms of section 27(1)(e) of the Act the suspension of levying of toll from 18h00 on 23 April 2022 at N2 Othongathi and N2 Mvoti for all vehicles for a period until access along R102 or M4 in vicinity of above plazas has been restored.
