The Independent Communications Authority of South Africa ("the Authority"), hereby publishes a notice inviting interested persons to public hearings in relation to an application received by the Authority from Telkom SA SOC Limited for the amendment of its Radio Frequency Spectrum Licence in the 2300 – 2360 MHz ("2300 MHz") and 2307 – 2387 MHz bands paired with the 2401 – 2481 MHz ("2400 MHz") band¹ in line with the provisions of regulation 9 of the Radio Frequency Spectrum Regulations, 2015², read with section 31 (3)(b) of the Electronic Communications Act, 2005 (Act No. 36 of 2005), as amended.
2. The Authority hereby invites interested persons and parties to the public hearings in relation to the above-mentioned application. The public hearings will be held virtually on Microsoft Teams ([public hearings](#)) on 27 May 2022.


