SOUTH AFRICAN PASSPORTS AND TRAVEL DOCUMENTS ACT, 1994**SEVENTEENTH AMENDMENT OF THE REGULATIONS MADE UNDER THE
SOUTH AFRICAN PASSPORTS AND TRAVEL DOCUMENTS ACT, 1994**

I, Dr P.A. Motsoaledi, the Minister of Home Affairs have, in terms of section 4(1)(e) of the South African Passports and Travel Documents Act, 1994 (Act No. 4 of 1994) and in consultation with the Minister of Finance, made the regulations in the Schedule.

SCHEDULE

Definition

1. In this Schedule “the Regulations” means the Regulations made under section 4(1)(e) of the South African Passports and Travel Documents Act, 1994 (Act No. 4 of 1994)(the Act), published under Government Notice No. R. 784 of 10 May 1996, as amended by Government Notice Nos. R. 1027 of 21 June 1996, R. 580 of 11 April 1997, R. 1564 of 21 November 1997, R. 353 of 13 March 1998, R. 384 of 24 March 1999, R. 251 of 17 March 2000, R. 314 of 30 March 2001, R. 409 of 28 March 2002, R. 1495 of 2 December 2002, R. 476 of 31 March 2003, R. 430 of 31 March 2004, R. 319 of 1 April 2005, R. 473 of 19 May 2006, R. 68 of 28 January 2008, R.346 of 27 March 2009 and R. 24 of 19 January 2011.

Substitution of regulation 16 of the Regulations

2. The following regulation is hereby substituted for regulation 16 of the Regulations:

“Fees

16. (1) The fees payable in respect of applications for a South African passport or travel document made within the Republic issued under the Act shall be as follows:

(a) Adult passport:

(i) 32 pages R600, 00;

(ii) 48 pages (maxi) R1 200, 00;

(b) Child passport R600, 00;

(c) Official passport R600, 00;

(d) Diplomatic passport R600, 00;

(e) re-application with old maxi passport R1 200,00;

(f) document for travel purposes R600,00; and

(g) crew member certificate R600, 00.

(2) The fees payable in respect of applications for a South African passport or travel document made outside of the Republic, at Missions, Embassies or Consulates, issued under the Act shall be as follows:

(a) Adult passport:

(i) 32 pages R1 200, 00;

- (ii) 48 pages (maxi)R2 400, 00
- (b) Child passport R1 200, 00; and
- (c) emergency travel certificate R140, 00.

(3) The fees payable in respect of the replacement of a lost, stolen or damaged South African passport, child passport, document for travel purposes, emergency passport, temporary passport or crew member certificate referred to in subregulation (1), shall be double the fee mentioned in that subregulation: Provided that in instances where the documents referred to was lost, stolen or damaged through no negligence on the part of the holder, only the fee mentioned in subregulation (1) shall be payable.

Short title and commencement

3. These Regulations shall be called the Seventeenth Amendment of the Regulations made under the South African Passports and Travel Documents Act, 1994 and will come into operation on 1 November 2022.
