

GENERAL NOTICE 1465 OF 2022

COMPENSATION FOR OCCUPATIONAL INJURIES AND DISEASES ACT, 1993 (ACT NO 130 OF 1993)

NOTICE ISSUED BY THE COMPENSATION COMMISIONER UNDER THE COMPENSATION FOR OCCUPATIONAL INJURIES AND DISEASES ACT, 1993

In terms of Section 6A (b) of the Compensation for Occupational Injuries and Diseases Act, 1993 (Act 130 of 1993 as amended by Act 61 of 1997), I, Vuyo Mafata, in my capacity as the Compensation Commissioner, and acting in terms of Section 4 (1) (I), wish to communicate the following:

- a) To remind Employers to submit all their outstanding Return of Earnings (ROE)
- b) To encourage Employers to submit their Returns through the ROE Online System platform (<u>cfonline.labour.gov.za</u>) or by completing the CF-2A/W.As.8 Form for submission via <u>cfcallcentre@labour.gov.za</u>
- c) Should Employers fail to submit all outstanding ROEs before 31 January 2023, the Compensation Fund will perform an estimation of the employers' earnings and issue a revised Notice of Assessment to the Employer whose legal obligation is to make payment thereof
- d) Compensation Fund (CF) will impose a 10% penalty on the final assessment on those Employers who fail to submit their ROEs by the due date
- e) Failure to make payment will result in interest being charged at the prevailing rate approved by the National Treasury on the overdue account.
