(ACT NO. 107 OF 1998)****CONSULTATION ON THE INTENTION TO EXTEND THE APPOINTMENT OF THE ENVIRONMENTAL ASSESSMENT PRACTITIONERS ASSOCIATION OF SOUTH AFRICA AS THE SINGLE REGISTRATION AUTHORITY IN TERMS OF SECTION 24H(3) READ WITH 24H(6) OF THE NATIONAL ENVIRONMENTAL MANAGEMENT ACT, 1998, FOR A PERIOD OF 12 MONTHS**

I, Barbara Dallas Creecy, Minister of Forestry, Fisheries and the Environment hereby consult on my intention to extend the appointment of the Environmental Assessment Practitioners Association of South Africa in terms of section 24H(3), read with section 24H(6), of the National Environmental Management Act, 1998 (Act No. 107 of 1998) for a period of 12 months.

The Environmental Assessment Practitioners Association of South Africa was appointed as the single registration authority for a period of five years, with effect from 8 February 2018 until 7 February 2023. The intention is to extend the appointment until 7 February 2024 to enable me to adequately consider what the most sustainable way forward for the long-term regulation of environmental assessment practitioners would be.
