THE SOUTH AFRICAN LEGAL PRACTICE COUNCIL**NOTICE IN TERMS OF RULES 2, 3, 4 & 5 OF THE LEGAL PRACTICE COUNCIL RULES**

The South African Legal Practice Council ("the Council") hereby issues a notice that it has resolved that the fees payable in respect of certain applications under Rule 2, the annual fees for Fidelity Fund Certificates under Rule 3, and annual fees payable by all legal practitioners under Rule 4 of the Legal Practice Council Rules are to be increased.

With effect from 1 January 2023, application fees provided for in Rule 2 (except for fees relating to the registration, examination and cession of practical vocational training contracts), the annual fees for Fidelity Fund Certificates under Rule 3 and the annual fees payable by all legal practitioners under Rule 4 will increase by 15%, rounded to the nearest R5.00.

Fees relating to the registration, examination and cession of practical vocational training contracts and the fees payable under Rule 5 in respect of examinations conducted by the Council are not being increased.

Schedule 1 to this notice reflects the fees (inclusive of Value Added Tax) currently payable to the Council, and the fees that will be payable from 1 January 2023.
