**NOTICE OF THE APPLICATIONS RECEIVED IN RESPECT OF THE
INVITATION TO PRE-REGISTER FOR COMMUNITY TELEVISION
BROADCASTING SERVICE AND RADIO FREQUENCY SPECTRUM LICENCES FOR
MULTIPLEX 1 FREQUENCIES**

1. The Independent Communications Authority of South Africa ("the Authority") hereby gives notice that it has received applications for pre-registration for community television broadcasting service and radio frequency spectrum licences in various provinces throughout the country.
2. The applications were submitted to the Authority pursuant to the Invitation to Pre-register ("ITP-R") published on 30 June 2022¹.
3. The Authority received thirty-seven (37) applications. Twenty (20) applications were admitted to Phase 1 of the ITP-R licensing process, whilst seventeen (17) applications were disqualified.

Interested parties are invited to lodge written representations in relation to the applications in Schedule A within fourteen (14) working days from the date of publication of this Notice in the Government Gazette. Written representations received after fourteen (14) working days will not be considered by the Authority.
6. Interested parties who lodge representations must also indicate whether they wish to make oral submissions should the Authority decide to hold public hearings in respect of the applications.
