**NOTICE OF INTENTION TO CANCEL THE REGISTRATION OF AN EMPLOYERS’  
ORGANISATION**

I, Lehlohonolo Molefe, Registrar of Labour Relations, hereby, in terms of section 106(2B) give notice of my intention to cancel the registration of **Midland Furniture Manufacturers’ Association (LR2/6/3/17)** for the following reasons:

- The organisation failed to comply with the provisions of section 98, 99 and 100 of the Act, and
- The organisation ceased to function in terms of its constitution

This office is of the view that the employers’ organisation ceased to function as a genuine employers organisation as envisaged by the Act

The organisation and all interested parties are hereby invited to make written representations as to why the registration should not be cancelled. **Only representations pertaining to this Notice will be considered. All correspondence should refer to case number: 2023/91.**
