(ACT 36 OF 1947)****PROHIBITION REGARDING THE USE OF CERTAIN AGRICULTURAL REMEDIES**

I, Angela Thoko Didiza, Minister of Agriculture, Land Reform and Rural Development acting under section 7bis the Fertilizers, Farm Feeds, Agricultural Remedies and Stock Remedies Act, 36 of 1947 (Act No.36 of 1947) 1947), hereby-

- (a) make it known that I intend to prohibit the use of agricultural remedies containing chlorpyrifos and cartap hydrochloride as active ingredients.
- (b) invite Interested persons to submit written comments or representations concerning the proposed prohibition and to do so within 60 days from the date of publication of this Public Consultation Notice to the following address:
