NOMINEES ELIGIBLE FOR APPOINTMENT AS MEMBERS OF THE TRANSPORT APPEAL TRIBUNAL (TAT)

Transport Appeal Tribunal (TAT) is a creature of statute established in terms of the Transport Appeal Tribunal Act, No. 39 of 1998. Section 12 of the said Act, provides that the Tribunal must consider an appeal noted with it in accordance with the National Land Transport Act, No. 5 of 2009, and the Cross-Border Road Transport Act, No. 4 of 1998; whereupon the Tribunal may-

- i. Reject the appeal and confirm the act, direction or decision appealed against.
- ii. Uphold the appeal, set aside the act, direction or decision appealed against by the appellant, and
- iii. Substitute the act, direction or decision of the relevant body or entity as the case may be with an act, direction or decision it should have performed or given as the case may be or
- iv. Refer the matter back for consideration to the relevant body or entity with recommendations on what should have been the act, direction or decision of the relevant body or entity
- v. Uphold the appeal partially and vary the act, direction or decision appealed against.

Section 4 of the Transport Appeal Tribunal Act, makes provision of the appointment of Tribunal Members by the Minister for the execution of the provisions of the said Act.

Therefore, the purpose of this notice is to inform the public that the persons mentioned below are eligible and being considered for Ministerial appointment as Members of the Tribunal and they are as follows:
