**FINANCIAL SECTOR REGULATION ACT, 2017:  
INVITATION FOR PUBLIC COMMENTS ON DRAFT DEPOSIT INSURANCE  
REGULATIONS**

Notice is hereby given, in terms of section 288(4)(a)(iv) of the Financial Sector Regulation Act, 2017 (Act No. 9 of 2017), inviting written submissions from the public on the draft Deposit Insurance Regulations ('the Regulations'). The Regulations set out necessary administrative and procedural matters to effectively implement the deposit insurance scheme in the Republic of South Africa.
