The Road Accident Fund is a national public entity established for the purpose of paying compensation in accordance with the provisions of the Road Accident Fund Act, 1996 (Act No. 56 of 1996) as amended, for loss or damage wrongfully caused by the driver of motor vehicles within the Republic of South Africa.

The Fund has a Board, whose function, amongst others, is to exercise the overall authority and control over the financial position, operation and management of the Fund. The Board serves for a period of three (3) years and is accountable to the Minister of Transport. The term of the office of the current Board expired on the 3rd of December 2022 and their term of office was extended until the appointment of the new Board.

An invitation for nomination was published in the *Gazette* and national news media for nominations of persons to serve on the RAF Board. The deadline for submission of nominations was 26 June 2023.
