In terms of section 13(2)(a) of the Lotteries Act 57 of 1997, interested parties who wish to operate the National Lottery and Sports Pools, upon expiration of the existing licences, are invited to apply for access to a copy of the Request for Proposal ("the RFP") for the Fourth National Lottery and National Sports Pools Licence.

The RFP and all other documentation related thereto will be available for purchase from the National Lotteries Commission ("the NLC") at its offices, or through the online virtual data room ("VDR"), from 31 August 2023 until 31 October 2023 upon the payment of the non-refundable RFP document fee of R55 000.00 (fifty-five thousand Rand). This fee shall be paid by way of an EFT or direct deposit into the NLC's bank account with the following details:

The NLC will provide interested parties with a copy of the RFP, together with an access link to the VDR, upon verification of receipt of the payment of the RFP document fee.

The NLC Board has requested interested parties who wish to submit a response to this RFP to attend a two-day briefing session which will be held on 30 August 2023 and 31 August 2023 from 10h00 to 17h00, with attendance being required for the full allotted time on both dates. Details of the briefing session will be published on the NLC's website in due course.

Prospective applicants for the Fourth National Lottery and National Sports Pools Licence must be represented by at least two individuals, who must attend the briefing session on behalf of the prospective applicant on both days. Applicants are required to submit their applications for the Fourth National Lottery and National Sports Pools Licence by Saturday 3 February 2024 at 12:00 PM South African Standard Time at the place and in a manner specified in the RFP.
