The Minister of Trade, Industry and Competition hereby invites nominations of persons to serve as Trustees of the NEF.

**Personal Requirements in Respect of Trustees**

The Trustees appointed to the NEF Board must be persons who are committed to (a) fairness, transparency and accountability on the part of those entrusted with the public office; and (b) the objects and principles of the Act.

When viewed collectively, the Trustees must (a) predominantly represent a broad cross-section of the historically disadvantaged persons of the Republic; (b) possess expertise and experience in the fields of, amongst others, law, economics, business practice, development practice, capital markets and finance; (c) be reasonably reflective of the gender composition of historically disadvantaged persons; and (d) be fairly representative of various provinces of the Republic.

**Disqualifications of Trustees**

A person may not be appointed as a trustee if such person (a) is not a citizen of the Republic; (b) is not permanently resident in the Republic; (c) has or acquires an interest in a business or enterprise which may conflict or interfere with the proper performance of the duties of a member of the Board; (d) is an unrehabilitated insolvent; (e) is of unsound mind or is subject to an order of a competent court declaring such person to be mentally ill or disordered; (f) has at any time been convicted, whether in the Republic or elsewhere, of theft, fraud, forgery and uttering, perjury, an offence in terms of the Corruption Act, 1992 (Act No. 94 of 1992), or any other offence involving dishonesty; or (g) has at any time been removed from an office of trust on account of misconduct.

**Term of office:** The term will be determined by the President on the advice of the Minister.

**Remuneration of Trustees:** Trustees will be remunerated according to the remuneration rates as determined and published by the National Treasury.

**Nomination Procedure:** Nominations must be submitted in writing and must contain the following information: Detailed curriculum vitae that includes membership of all boards the nominee currently serves on or has served on in the past ten (10) years, motivation for the appointment and certified copies of the identity document and qualifications obtained.

- three persons, each representing organised business, labour and civil society appointed on the basis of their knowledge and experience and expertise relevant to, and involvement in SEZs; and
- five independent persons appointed on the basis of their knowledge, experience and expertise relevant to SEZs.

**Disqualifications for membership**

A person may not be a member of the Advisory Board if that person: (a) is an unrehabilitated insolvent; (b) has been declared by a High Court with Jurisdiction to be mentally ill; (c) has been convicted of an offence in the Republic or elsewhere, other than an offence committed prior to 27 April 1994 associated with a political objective, and sentenced to imprisonment without the option of a fine or, in the case of fraud or any other offence involving dishonesty, to a fine or imprisonment or both a fine and imprisonment; (d) has at any time been removed from an office of trust on account of breach of fiduciary duties; or (e) is otherwise disqualified in terms of section 69 of the Companies Act, 2008.

**Term of office of the Advisory Council:**

The Advisory Board is appointed for a period of five (5) years.

**Remuneration of Members:**

Successful candidates would be remunerated according to the remuneration rates as determined and published by the National Treasury.
