## CIVIL AVIATION ACT, 2009 (ACT NO. 13 OF 2009)

MINISTERIAL ORDER REGARDING ADMINISTRATIVE SUPPORT TO THE AIR  
SERVICES LICENSING COUNCIL AND THE INTERNATIONAL AIR SERVICES COUNCIL

I, Lydia Sindisiwe Chikunga, Minister of Transport, by virtue of the powers vested in me by Section 100 of the Civil Aviation Act, 2009 (Act No. 13 of 2009) and after consulting the Director General (DG) on his powers as per Section 9 of the Air Services Licensing Act, 1990 (Act No. 115 of 1990) and Section 10 of the International Air Services Act, 1993 (Act No. 60 of 1993), do hereby make the following Ministerial Order:

1. The South African Civil Aviation Authority (SACAA) shall provide the necessary administrative support to the Air Services Licensing Council established in terms of section 3(1) of the Air Services Licensing Act, 1990 (Act No. 115 of 1990) and the International Air Services Council established in terms of section 3(1) of the International Air Service Act, 1993 (Act No. 60 of 1993). Administrative support shall include developing effective systems that shall enable smooth processing of the license applications and foreign operator permits, including the issuance and storage thereof.
2. The Director of Civil Aviation working closely with the Councils and respective Chairpersons shall send monthly reports in relation to the administrative tasks to the Director General.
3. To give effect to this Ministerial Order, the DG, the Director of Civil Aviation and the Chairpersons of Councils shall enter into an agreement which will clearly outline the administrative responsibilities between the parties.

This order shall remain in force and effect until repealed or replaced by a subsequent

order.
