

**NATIONAL TREASURY**

I, Enoch Godongwana, in my capacity as the Minister of Finance, MP hereby publish, in accordance with sections 20 and 25 of the Division of Revenue Act, 2023 (Act No. 5 of 2023), the attached Explanatory Memorandum and Schedules:

- (a) The disaster allocations and the conversion of Provincial Disaster Recovery Grant (PDRG) to Municipal Disaster Recovery Grant (MDRG in terms of sections 20 and 25 of the Division of Revenue Act, 2023 (Act No. 5 of 2023).
- (b) The Stopping and Reallocation of the Municipal Infrastructure Grant from local municipalities to their respective districts.

For ease of reference only and where applicable, the attached Schedules reflect the main allocations, first and second adjustments, and total adjusted allocations.

## **Explanatory Memorandum to the Allocations set out in the attached Schedule**

This Gazette is published in terms of the Division of Revenue Act, 2023, (Act No. 5 of 2023) (DoRA), and provides information regarding the disaster allocations and the conversion of disaster grants to municipalities in the 2023/24 financial year. It further provides for the stopping and reallocation of funds to municipalities and reallocated to their districts.

The disaster allocations and the conversion of conditional grants is done in terms of sections 20 and 25 of DoRA.

### **ALLOCATION AND CONVERSION OF DISASTER FUNDS:**

The Department of Cooperative Governance (DCoG) has been leading the coordination and intervention actions to manage the aftermath of the floods in the affected provinces through the National Disaster Management Centre (NDMC). As a result, in accordance with section 23(3) of the Disaster Management Act, 2002 (Act No.57 of 2002), the NDMC issued a notice classifying the incident as a national disaster. On February 13, 2023, a notice to that effect was published in the Gazette (No. 48036).

National Treasury has approved an amount of R509 million requested by NDMC to address the aftermath of the floods in the six affected Provinces. The submission was received at a time whereby the Division of Revenue Bill had not yet been enacted thus posing some limitation to the amount that can be released at that time. From the total R509 million requested approved, only 45 percent (R344 million) of the MDRG's 2022/23 allocation could be released to the affected municipalities. After the enactment of the Division of Revenue Act, National Treasury has proceeded to gazette, convert and release the remaining allocation to fund the disaster funding.

This publication also gazettes the conversion of the Provincial Disaster Recovery Grant (PDRG) to Municipal Disaster Recovery Grant due to a shortfall in the municipal disaster allocation. An amount of R145.8 million is being converted to MDRG to respond to the disasters that occurred.

### **STOPPING AND REALLOCATION:**

The Department of Cooperative Governance approached National Treasury regarding municipalities in the Free State province that have been struggling to fully spend the Municipal Infrastructure Grant allocated to them. The affected municipalities (Mohokare, Kopanong, and Masilonyana local municipalities) would have their funds reallocated to their respective district for implementation of the projects on behalf of the underperforming local municipalities.
