ELECTORAL COMMISSION**NOTICE 2280 OF 2024****ELECTORAL COMMISSION****DETERMINATION OF SEATS RESERVED FOR EACH REGION FOR ELECTIONS OF THE NATIONAL ASSEMBLY**

The Electoral Commission hereby calls on persons and interested parties to make representations and submissions on the determination of seats reserved for each region for the election of the National Assembly -

- (a) Schedule 1A to the Electoral Act, Act 73 of 1998; (as amended by the Electoral Amendment Act, 1 of 2023) (“the Electoral Act”) provides that the Commission must determine a fixed number of seats reserved for each region for every election of the National Assembly.
- (b) The determination of the number of seats must be made by taking into account available scientifically based data in respect of voters and representation by interested parties.
- (c) The scientifically based data in respect of voters is the voters’ roll as at 22 January 2024.
- (d) The determination by the Commission is in relation of half of the seats (200) in the National Assembly in terms of Item 1(a) to schedule 1A of the Electoral Act. The Commission makes the determination using the formula and the Drop Quota as follows:
$$\frac{A}{B+1} + 1$$

A represents the number of registered voters (26 960 484) as at 22 January 2024

B represents the total number of regional seats in the National Assembly (200)

The result of this calculation, disregarding fractions, represents the quota of registered voters per regional seat.

The calculation of seats in the regions will be based on the total number of registered voters in the region divided by the quota.

- (e) The table below describes the current allocation of seats and the indicative seats to be determined based on current voter registration data.

- (f) Interested Parties are invited to make representations to be considered by the Commission before it determines the number of seats. At the point of making the determination, the Commission will update the indicative seats to reflect the voters' roll data following the registration weekend still to be held in February 2024.
