**EXTENSION OF THE CLOSING DATE FOR THE SUBMISSION OF PUBLIC COMMENTS ON WHITE PAPER ON HUMAN SETTLEMENTS**

On 18 December 2023, the Department of Human Settlements (DHS) invited the public to submit comments on the White Paper on Human Settlements. The DHS published in the Government Gazette no: 49895, Vol 702, 2023 with the to 31 January 2024 as the closing date for the submission of public comments. This closing date was extended to 28 February 2024.

The DHS has since received further requests from various organisations and individuals for the extension of the closing date for the submission of public comments. While the DHS has received substantial public comments on the White Paper, in the spirit of promoting maximum public participation, the closing date for the submission of public comments is hereby extended to 15 March 2024.
