WITHDRAWAL OF A SECTION OF NATIONAL ROAD N1 SECTION 29X AS A TOLL ROAD

By virtue of Section 27(1)(a)(ii) of The South African National Roads Agency Limited and National Roads Act, 1998 (Act No. 7 of 1998), I hereby amend Declaration No. 1241 of 1998, by withdrawing the section of the alignment of the National Road N1 Section 29X through the town of Musina, from the intersection with the Musina Western Ring Road in line with point R4 of Declaration No. 345 of 2013 on Sheet 1 of Plan No. P807/12, through the town of Musina, up to the intersection with the Musina Western Ring Road in line with point R109 of Declaration No. 345 of 2013 on Sheet 5 of Plan No. P807/12, as a Toll Road.

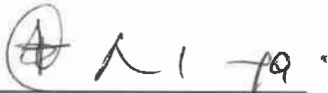

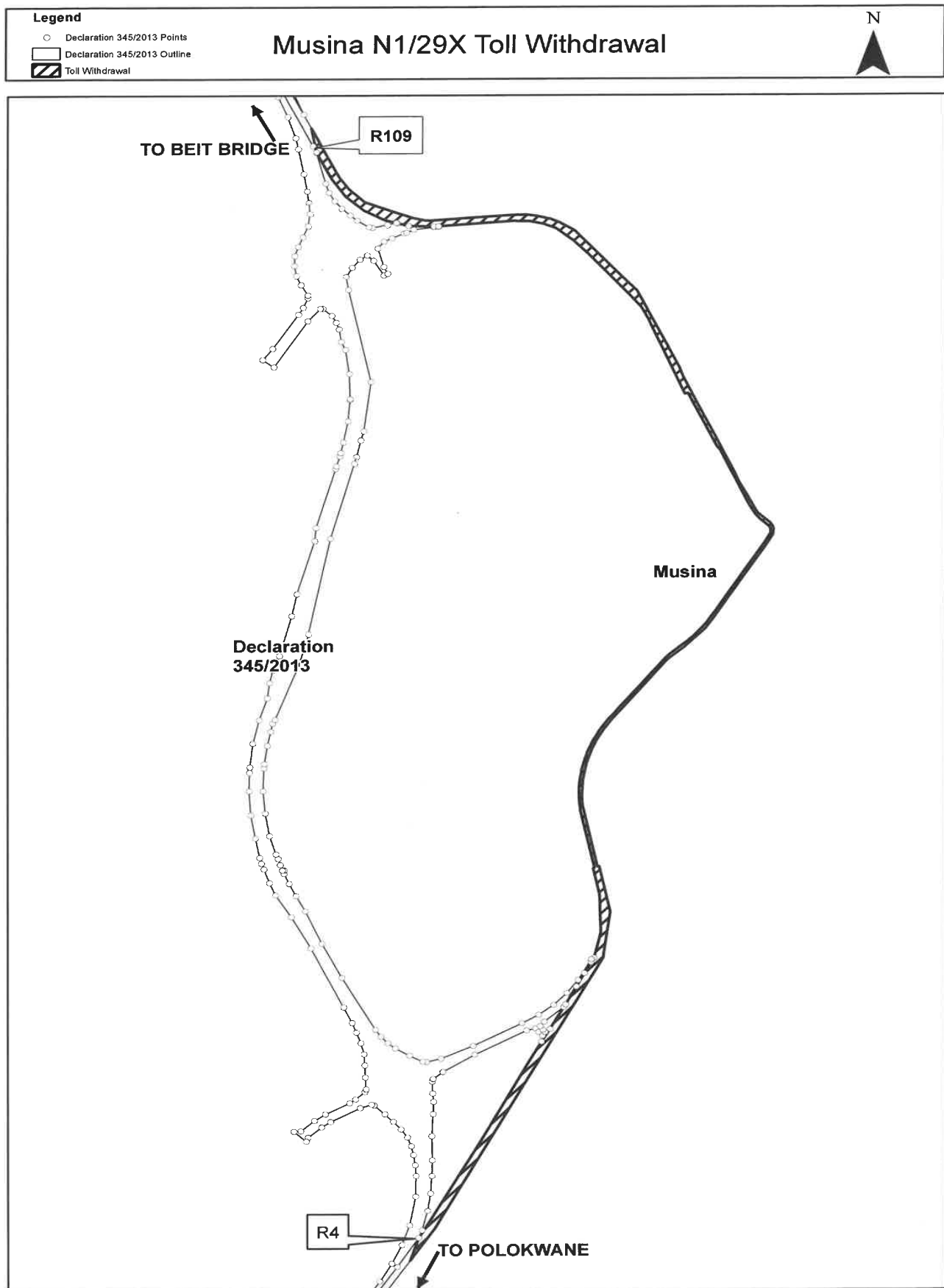
