

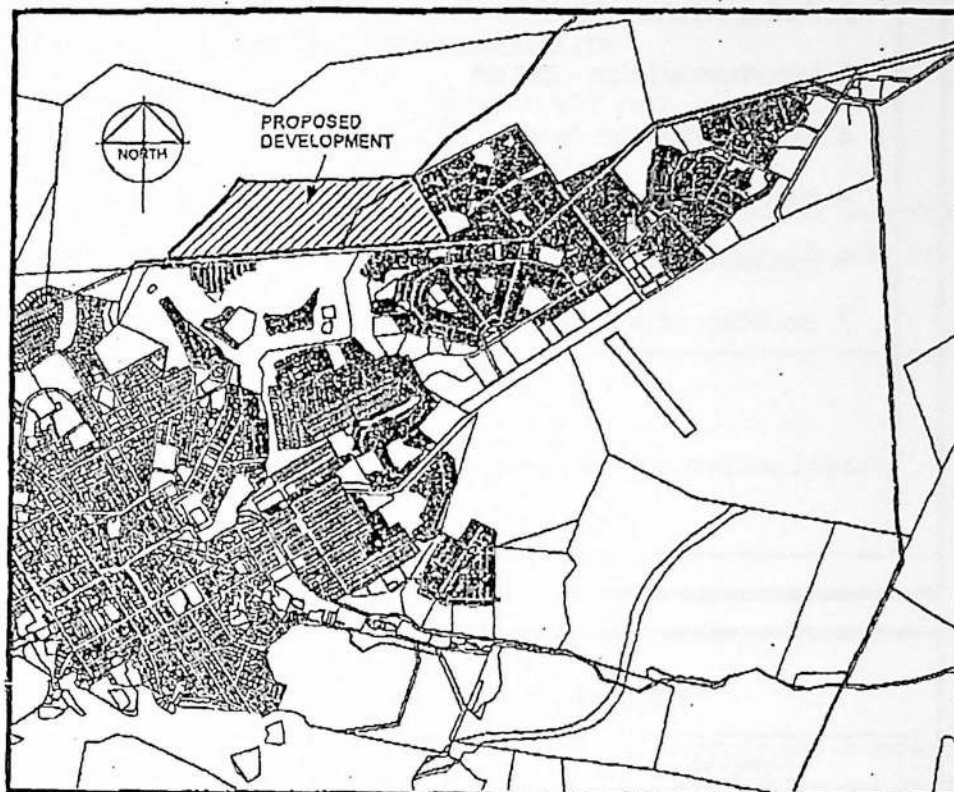

It is hereby published for general information that the Municipal Council of Ndlambe, acting under the authority of section 11 (3) (m) of the Local Government: Municipal Systems Act, 2000 (Act No. 32 of 2000), read with sections 22 (2) (d) and 42 (b) of the Eastern Cape Liquor Act, 2003 (Act No. 10 of 2003), taken decision on and passed a by-law on liquor trading hours and ward committee meetings.

1. Definitions

In these By-laws words or expression to which a meaning has been assigned in the Eastern Cape Liquor Act, 2003 (Act No. 10 of 2003), shall bear that meaning unless the context indicates otherwise; and—

“Council” means the Municipality of Ndlambe, its successor in law, or its executive committee or any other body acting by virtue of powers delegated to it by Council as well as any officer to whom the Council has delegated any powers and duties with regard to this by-law, and

"Liquor Act" means the Eastern Cape Liquor Act (Act No. 10 of 2003);

"Liquor Board" means the Eastern Cape Liquor Board established by section 4 of the Liquor Act.

2. Application of by-law

- (1) This by-law shall be applicable in respect of all registered premises situated within the area of jurisdiction of the Council.
- (2) The Council has determined the trading hours of the different kinds of registration listed in the first Column of the Schedule as the trading hours listed in the second Column of the said Schedule.
- (3) A departure from the hours stipulated in the Schedule shall be on application and approval by the Council.
- (4) The Council reserves to itself the right to depart from the stipulated hours of trading in the interest of the community.

3. Ward Committee consultative meetings

- (1) The Ward Committees must, upon receipt of a notice of application for registration, in terms of section 22 (2) (d) (1) of the Liquor Act hold consultative meeting with the owners of immovable property in the immediate vicinity of premises that are sought to be registered to discuss and solicit their views with regard to the application that the applicant intends to lodge with the Liquor Board.
- (2) The Ward Committee must compile a report and submit it to the Liquor Board and Council, stipulating the date, time, the names and the addresses of the people who attended, indicate whether it objects to or recommends the application and what additional conditions it proposes, if any.
