Under the powers vested in me by section 25(4) of the Local Government: Municipal Structures Act, 1998 (Act No. 117 of 1998), I, **SM Mlameli**, Member of the Executive Council responsible for Cooperative Governance, Traditional Affairs and Human Settlements in the Free State Province and after consultation with the Electoral Commission, hereby call a by-election and set 13 June 2012 as the date for the by-election to be held in Ward 33 of the Local Municipality of Matjhabeng.
