AMENDMENT OF NOTICE ESTABLISHING THE WEST RAND DISTRICT MUNICIPALITY (NOTICE NO. 4862 OF 2005)

Notice No. 4862 of 2005, published in the Gauteng Provincial Gazette Extraordinary No. 527 dated 6 December 2005, as amended, is hereby further amended by amending the Schedule thereto as follows:

AMENDMENT OF PART 2

1. *Amendment of clause 2*

Clause 2 is hereby amended by the deletion of sub-clause (2).

AMENDMENT OF PART 3

2. *Amendment of clause 10*

Clause 10 is hereby amended by the substitution therefor of the following clause:

"10. For that part of the district municipal area indicated by Map No. DC48 GT481, published under General Notice No. 5359 of 2007 in Gauteng Provincial Gazette Extraordinary No. 362 dated 14 December 2007, a new local municipality called the Mogale City Local Municipality is hereby established with effect from the effective date.

3. *Amendment of clause 13*

Clause 15 is hereby amended by the substitution for sub-clause (1) of the following sub-clause:

"(1). The boundaries of the Mogale City Local Municipality are as indicated in Map No. DC48 GT481, published under General Notice No. 5359 of 2007 in Gauteng Provincial Gazette Extraordinary No. 362 dated 14 December 2007, and attached hereto as Annexure "B".

AMENDMENT OF PART 7**4. *Amendment of clause 39***

Clause 39 is hereby amended by the deletion of sub-clause (2)(b).

AMENDMENT OF PART 8**5. *Amendment of clause 40***

Clause 40 is hereby amended by the addition of the following sub-clause after sub-clause (2):

- “(3). The Mogale City Local Municipality, as from the effective date, becomes the successor-in-law of the West Rand District Municipality as far as it relates to that portion of the district management area that has been included in the Mogale City Local Municipality as provided for in General Notice No. 3226 of 2008, published in Gauteng Provincial Gazette Extraordinary No. 237 dated 29 August 2008.
