Subdivision of Agricultural Land in respect of the Remainder of Portion 100 (of 80) of the Farm Lot 61 No. 1521.

Provincial Roads Act No. 4 of 2001 – The approval from the relevant controlling authority has already been obtained.

National Roads Act No.7 of 1998 – the approval from the relevant controlling authority has already been obtained.

12. Suspension of Restrictive Conditions of Title

In terms of Section 33(2)(d) of the DFA, the following conditions of title are suspended which suspension will come into effect when published in the Provincial Gazette in terms of Section 33(4) and will be removed in terms of Section 34(3) when the township register is opened:

C, E, F (i) & (ii) and G (a) & (b).

This approval shall not exempt the applicant from the provisions of any other law.

13. Comments from the Department of Agriculture and Environmental Affairs.

The Development shall not commence prior to the applicant obtaining environmental approval from the responsible authority in terms of the Environmental Conservation Act (Act 73 of 1989) as amended. The conditions of approval as set out in the Record of Decision (EIA 6331) issued by the Department of Agriculture and Environmental Affairs, together with the requisite conditions set out in the Environmental Management Plan prepared by Messrs. SDP cc. shall be adhered to.

An Accredited Environmental Control Officer shall be appointed by the developer, and monthly progress reports (including monitoring, compliance as well as mitigatory measures taken) shall be submitted to the KwaDukuza Municipality as well as the Monitoring and Compliance Section of the Department of Agriculture and Environmental Affairs.

The archaeological mitigation as identified within the Archaeological Report and authorized and approved by Amafa, shall be carried out to the satisfaction of Amafa before construction commences.

14. Comments from the Department of Water Affairs and Forestry

The conditions of approval as set out in the letter of authority from the Department of Water Affairs and Forestry, issued on the 5th of February 2006 and the 11th of February 2006 shall be adhered to.

15. Comments from Amafa

The archaeological mitigation as identified within the Archaeological Report and authorized and approved by Amafa, shall be carried out to the satisfaction of Amafa before construction commences.

A. CONDITIONS OF TITLE**1. Home Owners Association**

A Home Owners Association (HOA) shall be formed and all owners shall become members of the H.O.A. and ascribe to the rules and regulations of the Association and no erf / sectional title unit / real right shall be transferred without the consent of the H.O.A., which consent may not be withheld if the new buyer agrees to become a member of the Association.

(a) Home Owners' Association

Neither the subdivision, nor any further subdivision, nor any improvement thereon, as defined in the Sectional Title Act No.95 of 1986, shall be transferred to any person until he has bound himself to become and remain a member of the "Home Owners' Association" for the duration of the ownership, and a clearance certificate has been issued by such association to the effect that its articles of association have been complied with.

2. Omnibus servitude for services

All Erven (Excluding all Erven to be transferred to the HOA) shall be subject to the following condition relating to servitudes for the provision of storm water drainage, water supply, sewerage, electricity, gas and/or fuel supply, telecommunications, radio and television services, over or under the land, along any one boundary thereof, other than a road frontage and within a distance of 2 metres from one such boundary.

Reasonable access shall be provided to such servitude at all times for the purpose of installation, maintenance, removal, or extension of such services. The owner of the land shall without compensation be obliged to allow the servicing of any other land or street to be conveyed along such servitude; provided that if the owner of the land be aggrieved by the unreasonable exercise of these rights, he shall have the right of appeal to the Minister whose decision shall be final.

No buildings or other structures shall be erected within the aforesaid servitude area and no large-rooted trees shall be planted within the area of such servitude or within 1 metre thereof nor shall the ground level therein be altered without the written consent of the HOA.

Maintenance shall include cutting, trimming, or otherwise dealing with vegetation so as to prevent interference with any service. The right conferred by this condition shall be exercised by the local authority and or HOA or any other body or person legally authorised to provide such services for the benefit of the inhabitants of the township.

The owner of the erven shall, without compensation, be obliged to permit such deposit of material or excavation.

Encroachment over this servitude shall be at the discretion of the Local Municipality and the HOA.

3. Private Roads Infrastructural Servitude

All Erven intended for Private Roads shall be subject to the following condition over the entire width:

The Local Municipality, Siza Water and HOA shall, without compensation, have the right to erect, lay and maintain roads, sewers, drains, water supply piping within such servitude and electricity mains under ground and shall have reasonable access thereto for the purposes of maintenance, removal or extension and the owner of the land shall, without compensation, be obliged to allow the sewerage and drainage of any other land or street to be conveyed along such sewers and drains and shall not permit such drain to be damaged or allow material from whatever source to impede the flow of water within it.

The Local Municipality, Siza Water and / or HOA shall be entitled to deposit temporarily on the land adjoining the aforesaid servitude such material as may be excavated by it during the course of construction, maintenance or removal of such works as it, in its discretion, may deem necessary and shall further be entitled to reasonable access to the said land for the aforesaid purpose, subject to any damage done during the process of the construction, maintenance or removal of such sewerage mains and other works being made good by the Service Provider or HOA.

The owner of the erven shall, without compensation, be obliged to permit such deposit of material or excavation.

Encroachment over this servitude shall be at the discretion of the Local Municipality and the HOA.

4. Water Pipeline Servitude

Erven 1082-1087, 1030, 1017, 1016, 1009, 1005, 1024 and 1052 shall be subject to a 6m wide water pipeline servitude marked on plan MRVE DFA 01_06 Rev 2 which is to be registered in favour of Umgeni Water.

5. Sewer and Drain Servitude

The developer hereby grants Simbithi the right to register a servitude, at Simbithi's cost, to carry a sewerage line over erven 1195, 1207 and 1173 of the Developer's property. The final route will be determined by the Developers engineer.

The Security Servitude shall be subservient to the 6m Water Pipeline Servitude in favour of Umgeni Water over Erven 1082 - 1087).

8. Non-Building Servitude

Erven 1082-1087, 1185-1194, shall be subject to a 10m wide Non-building Servitude for planting purposes marked on plan MRVE DFA 01_06 Rev 2 which is to be registered in favour of the HOA and in favour of Erven 793 to 800 Salt Rock, and the registration of the servitude shall be at the developer's cost and shall be subject to the acceptance of the servitude in writing, by the registered owners of Erven 793 to 800, within 60 days of being notified of the intention of the developer to register the servitude. Prior to the registration of the servitude in favour of Erven 793 to 800 Salt Rock, the developer shall inform The Non-Building Servitude shall be subservient to the 6m Bulk Water Pipeline Servitude in favour of Umgeni Water over Erven 1082 - 1087).

Erven 987 and 989 shall be subject to a 10m wide Non-building Servitude for planting purposes marked on plan MRVE DFA 01_06 Rev 2 which is to be registered in favour of the HOA and in favour of the following Lots, all of Lot 71 No. 1524;

- Portion 50 (of 14) of Lot 71 No. 1524
- Portion 184 (of 51) of Lot 71 No. 1524
- The Rem of Portion 21 (of 12) of the Farm Lot 71 No. 1524
- Portion 56 (of 31) of the Farm Lot 71 No. 1524
- Portion 130 (of 69) of the Farm Lot 71 No. 1524
- Portion 146 of the Farm Lot 71 No. 1524
- Rem of Portion 11 (of 9) of the Farm Lot 71 No. 1524

The registration of the servitude shall be at the developer's cost and shall be subject to the acceptance of the servitude in writing, by the registered owners of the Erven here above, within 60 days of being notified of the intention of the developer to register the servitude.

PART C REASONS FOR JUDGEMENT

1. The proposed development complies with the principles set out in Chapter 1 of the Development Facilitation Act in that it is an infill urban development which will promote efficient and integrated development, which takes into account the social, economic, institutional and physical aspects of land development and which integrates the immediate communities through a system of corridors and activity and open space corridors. The development furthermore provides a variety of development and investment opportunities which will involve a diverse combination of land uses for the area. In addition the development will provide considerable employment opportunities both during the construction phase and on a permanent basis.
2. The development complies with the local Integrated Development Plan and Spatial Development Framework and the development is fully supported by the KwaDukuza Municipality.
3. The Services Agreement with the respective service providers to comply with the provisions of Section 40 of the Development Facilitation Act.
4. The development is a phased development and the phasing will need to get regulated by the pace of the provision of the bulk services.
5. The Department of Agriculture and Environmental Affairs has issued a Record of Decision containing a number of conditions which have been accepted by the applicant. In addition the Department of Local Government and Traditional Affairs has indicated support for the application, and the responses from other government departments and the Department of Agriculture has indicated that they do not object to the development.
6. There are no land claims attached to the development.
7. The concerns and reservations of the development by the objectors have been reasonably dealt with both by the applicant and also by amendments made by the Tribunal to the Conditions of Establishment.

"Special Residential Low Impact" – Provides for land and buildings for a low density residential development with a limited number of compatible ancillary land uses permissible so as to cater for everyday needs of the residents. The density is low and amenity high.

"Suburban Office – Mt. Richmond" – Provides for office development as the primary developmental focus in suburban location, and may include developments and buildings associated with public and private transportation in all its forms.

"General Mixed Use" – Provides for the development of a range of complementary land uses with varying degrees of mix: retail / commercial / business, services, administrative, community, worship, educational, environmental and residential buildings and hotels and related opportunities which will not breach the level of amenity contemplated by the zone. and may include developments and buildings associated with public and private transportation in all its forms.

"Institutions" – Provides for land and buildings used for accommodation and care of the aged.

"Active Open Space" – Provides for the development and Management of a system of sustainable open spaces used for green lungs and sporting and recreational activities and may include ancillary facilities and buildings subject to compliance with requirements set out in an EMP to be prepared by an accredited Environmentalist.

"Eco-Lodge" – This is a zone that manages the use of land for eco-tourism or nature based tourism development. The main focus is on accommodation in the form of a lodge, bush camp, cultural village and Bed and Breakfast / Guest House, and it includes a Restaurant not exceeding 200m² in GLA and a curio shop not exceeding 60m².

"Duet House" means a building designed or constructed or adapted to contain two self-contained dwelling units, separated horizontally and with individual access.

"Public and Private Transportation" means Land, buildings, or part of a building used for the purpose of parking buses or taxis, or as a transport station and associated parking area.
