NATIONAL ENVIRONMENTAL MANAGEMENT: WASTE ACT, 2008 (ACT 59 OF 2008)**INDUSTRY WASTE MANAGEMENT PLANS**

I, Anton Bredell, Provincial Minister of Local Government, Environmental Affairs and Development Planning in the Western Cape, under section 28(2) of the National Environmental Management: Waste Act, 2008 (Act 59 of 2008) (the Waste Act), require each manufacturing company within the Paint, Ink, Adhesive, Cosmetic, Pharmaceutical and Cleaning Chemicals subsectors of the Consumer Formulated Chemical Sector in the Western Cape who generate on average more than 20 kg of hazardous waste per day, to prepare and submit an Industry Waste Management Plan for approval.

The Industry Waste Management Plan must include the following information:

- (a) the amount of waste generated;
- (b) measures taken to prevent pollution or ecological degradation;
- (c) targets for waste minimisation, which can include re-use, recycling, recovery, cleaner production and resource efficiency;
- (d) measures or programmes to minimise the generation of waste, that can include re-use, recycling or recovery, and the final disposal of waste;
- (e) measures or actions to be taken to manage waste;
- (f) measures to reduce or eliminate the use and generation of hazardous chemical substances;
- (g) opportunities for the reduction of waste generation through changes to packaging, product design or production processes;
- (h) mechanisms for informing the public of the impact of waste-generating products or packaging on the environment;
- (i) the extent of any financial contribution to be made to support consumer-based waste reduction programmes;
- (j) the period required for implementation of the plan;
- (k) methods for monitoring, evaluation and reporting; and
- (l) any other matters that may be necessary to give effect to the objects of the Waste Act.

As required by section 31(1) of the Waste Act, appropriate steps must be taken to bring the contents of a proposed Industry Waste Management Plan to the attention of relevant organs of state, interested persons and the public. Any comments submitted in respect of an Industry Waste Management Plan must be considered by the person responsible for preparing the plan, as contemplated in section 31(3) of the Waste Act.

The Industry Waste Management Plans, together with a copy of all the comments received, must be submitted to the Department of Environmental Affairs and Development Planning within 18 months of publication of this notice by—

Upon receipt, an Industry Waste Management Plan will be considered under section 32 of the Waste Act and must be reviewed in terms of section 34 of the Waste Act.

A guideline providing assistance on the development of an Industry Waste Management Plan, entitled *Industry Waste Management Plan Guideline, March 2011*, has been published by the Department of Environmental Affairs and Development Planning. It must be noted that failure to submit or prepare an Industry Waste Management Plan when required to do so constitutes an offence in terms of section 67(1)(c) of the Waste Act and upon conviction, a person may be liable to a fine or imprisonment or to both a fine and imprisonment.

“NATIONAL ENVIRONMENTAL MANAGEMENT: WASTE ACT, 2008” (WET 59 VAN 2008)**NYWERHEIDSAFVALBESTUURSPLANNE**

Kragtens artikel 28(2) van die “National Environmental Management: Waste Act, 2008” (Wet 59 van 2008) (“Waste Act”), vereis ek, Anton Bredell, Provinsiale Minister van Plaaslike Regering, Omgewingsake en Ontwikkelingsbeplanning in die Wes-Kaap, van elke vervaardigingsmaatskappy in die Verf-, Ink-, Kleefmiddel-, Kosmetiese, Farmaseutiese en Skoonmaakchemikalieë-subsektore van die Verbruikersgeformuleerde Chemiese Sektor in die Wes-Kaap wat daaglik gemiddeld meer as 20 kg gevaarhoudende afval genereer, om ’n Nywerheidsafvalbestuursplan vir goedkeuring voor te berei en in te dien.

Die Nywerheidsafvalbestuursplan moet die volgende inligting insluit:

- (a) die hoeveelheid afval wat gegenereer word;
- (b) maatreëls wat geneem word om besoedeling of ekologiese agteruitgang te voorkom;
- (c) mikpunte vir afvalminimalisering, wat hergebruik, herwinning, skoner vervaardiging en hulpbrondoeltreffendheid kan insluit;
- (d) maatreëls of programme om afvalgenerering te minimaliseer, wat hergebruik of herwinning kan insluit, en die finale beskikking van afval;
- (e) maatreëls of handelinge wat geneem moet word om afval te bestuur;
- (f) maatreëls om die gebruik en generering van gevaarhoudende chemiese stowwe te verminder of te elimineer;
- (g) geleenthede vir die vermindering van afvalgenerering deur veranderings aan verpakking, produkontwerp of vervaardigingsprosesse;
- (h) meganismes om die publiek bewus te maak van die impak van afvalgenereringsprodukte of verpakking op die omgewing;
- (i) die omvang van enige finansiële bydrae wat gemaak moet word ter ondersteuning van verbruikersgebaseerde afvalvermindering-programme;
- (j) die tydperk benodig vir implementering van die plan;
- (k) metodes vir monitering, evaluering en rapportering; en
- (l) enige ander aangeleenthede wat nodig kan wees om uitvoering te gee aan die oogmerke van die “Waste Act”.

Soos vereis by artikel 31(1) van die “Waste Act”, moet toepaslike stappe gedoen word om die inhoud van ’n voorgestelde Nywerheidsafvalbestuursplan onder die aandag van tersaaklike staatsorgane, belanghebbendes en die publiek te bring. Enige kommentaar wat ten opsigte van ’n Nywerheidsafvalbestuursplan voorgelê word, moet deur die persoon verantwoordelik vir die voorbereiding van die plan oorweeg word, soos beoog in artikel 31(3) van die “Waste Act”.

Nywerheidsafvalbestuursplanne, tesame met ’n afskrif van alle kommentaar ontvang, moet binne 18 maande van die publikasie van hierdie kennisgewing by die Departement van Omgewingsake en Ontwikkelingsbeplanning ingedien word deur dit te—

- (e) imigqaliselo okanye amanyathelo amawathatyathwe ukulawula inkunkuma;
- (f) imigqaliselo yokunciphisa okanye yokuyekisa ukusetyenziswa nokwenziwa kwezinto eziqulathe imichiza eyingozi;
- (g) amathuba okunciphisa ukudaleka kwenkunkuma ngokwenza iinguqu kwindlela yokupakisha, ukuyilwa kwemveliso okanye iinkqubo zokuvelisa;
- (h) iindlela zokwazisa uluntu ngempembelelo yeemveliso ezidala inkunkuma okanye upakisho ngendlela edala inkunkuma kwindalo nokuyingqongileyo;
- (i) isixa salo naliphi na igalelo lemali emalifakwe ukuxhasa iinkqubo zokunciphisa inkunkuma edalwa ngumthengi;
- (j) ixesha elifunekayo ukusebenzisa isicwangciso eso;
- (k) iindlela zokubek' esweni, ukuvavanya nokunika ingxelo; kwakunye
- (l) nayiphi na imiba engaba yimfuneko ukuze ibe neziphumo kwiinjongo zomthetho i-Waste Act.

Njengoko kufunwa licandelo 31(1) lomthetho i-Waste Act, kufuneka kuthathwe amanyathelo afanelekileyo ukwazisa amaqumrhu karhulumente afanelekileyo, abantu abanomdla noluntu ngokubanzi ngeSicwangciso soLawulo lweNkunkuma yeMizi-mveliso esichaziweyo. Naziphi na izimvo ezifakwe ngokweSicwangciso sokuLawulwa kweNkunkuma yeMizi-mveliso kufuneka zithathelwe ingqalelo ngumntu onoxanduva lokulungiselela isicwangciso, njengoko kuchaziwe kwicandelo 31(3) le-Waste Act.
