PASSING OF CERTAIN LAND IN THE DISTRICT OF MOUNT CURRIE IN THE PROVINCE OF NATAL TO THE REPUBLIC OF TRANSKEI

Under the powers vested in me by section 1 of the Borders of Particular States Extension Act, 1980 (Act 2 of 1980), I hereby determine that the land mentioned in the accompanying Schedule, situated in the District of Mount Currie in the Province of Natal, shall with effect from 1 May 1985, cease to be part of the Republic of South Africa and become part of the Republic of Transkei
