MARKETING ACT, 1937.

LEVY ON MEALIES GROUND, CRUSHED, GRISTED OR OTHERWISE PROCESSED.

In terms of sub-section (1) of section *twenty-nine* of the Marketing Act, 1937 (Act No. 26 of 1937), I, WILLIAM RICHARD COLLINS, Minister of Agriculture and Forestry, hereby notify that the Mealie Industry Control Board referred to in section *two* of the Mealie Control Scheme, published under Proclamation No. 77 in *Government Gazette* No. 2629 of the 21st April, 1939, has, in terms of sub-section (1) of section *twenty-four* of that scheme and with my approval imposed the following levy:—

There is hereby imposed on all mealies ground, crushed, gristed or otherwise processed by any person dealing in the course of trade with mealies or mealie products, a levy of three farthings per bag of 200 lb. net weight of such mealies.

And I do further notify that the said levy shall become operative from the date of publication of this notice.

Ooreenkomstig subartikel (1) van artikel *nege-en-twintig* van die Bemarkingswet, 1937 (Wet No. 26 van 1937), maak ek, WILLIAM RICHARD COLLINS, Minister van Landbou en Bosbou, hierby bekend dat die Raad van Beheer oor die Mielienywerheid, genoem in artikel *twee* van die Mielie-reëlinskema wat by Proklamasie No. 77 in *Staatskoerant* No. 2629 van 21 April 1939 gepubliseer is, kragtens subartikel (1) van artikel *vier-en-twintig* van daardie skema en met my goedkeuring die volgende heffing opgelê het:—

Hierby word op alle mielies wat gemaal, gebreek, tot gruis gemaak of andersins verwerk word deur iemand wat as 'n besigheid met mielies of mielieprodukte handel 'n heffing van drie-kwart pennie per sak van 200 pond netto gewig van daardie mielies gelê.

En ek maak hierby verder bekend dat genoemde heffing vanaf datum van publikasie van hierdie kennisgewing van krag word.

MARKETING ACT, 1937.

LEVY ON MEALIES AND MEALIE PRODUCTS.

In terms of sub-section (1) of section *twenty-nine* of the Marketing Act, 1937 (Act No. 26 of 1937), I, WILLIAM RICHARD COLLINS, Minister of Agriculture and Forestry, hereby notify that the Mealie Industry Control Board referred to in section *two* of the Mealie Control Scheme published under Proclamation No. 77 in *Government Gazette* No. 2629 of the 21st April, 1939, has in terms of sub-section (1) of section *twenty-five* of that scheme and with my approval imposed the following levy:—

There is hereby imposed on all mealies or mealie products received from or delivered by a producer of mealies, after the thirtieth day of April, 1939, as the result of a purchase or other acquisition before or after that date, a levy of four shillings per bag of 200 lb. net weight in the case of mealies and 193 lb. net weight in the case of mealie products.

The foregoing levy is imposed in substitution for the levy made known by Government Notice No. 1005 of 1938, as amended by Government Notice No. 1445 of 1938.

And I do hereby further notify that the said levy shall become operative as from date of publication of this notice.

Government Notices Nos. 1005 and 1445 of 1938 are hereby cancelled.

HEFFING OP MIELIES EN MIELIEPRODUKTE.

Ooreenkomstig subartikel (1) van artikel *nege-en-twintig* van die Bemarkingswet, 1937 (Wet No. 26 van 1937), maak ek, WILLIAM RICHARD COLLINS, Minister van Landbou en Bosbou, hierby bekend dat die Raad van Beheer oor die Mielienywerheid, genoem in artikel *twee* van die Mieliereëlinskema wat by Proklamasie No. 77 in *Staatskoerant* No. 2629 van 21 April 1939 gepubliseer is, kragtens subartikel (1) van artikel *vyf-en-twintig* van daardie skema en met my goedkeuring die volgende heffing opgelê het:—

Hierby word 'n heffing van vier sjielings per sak van 200 pond netto gewig in die geval van mielies en 193 pond netto gewig in die geval van enige mielieproduk gelê op alle mielies en mielieprodukte wat na die dertigste dag van April 1939 ontvang word van of gelever word deur 'n produsent van mielies as gevolg van aankoping of verkryging op ander wyse voor of na daardie datum.

Die voorgaande heffing word opgelê ter vervanging van die heffing bekendgemaak by Goewermentskennisgewing No. 1005 van 1938, soos gewysig by Goewermentskennisgewing No. 1445 van 1938.

En, ek maak hierby verder bekend dat genoemde heffing vanaf datum van publikasie van hierdie kennisgewing van krag word.
