Ek, NICOLAAS CHRISTIAAN HAVENGA, Minister van Finansies, stel hierby, ingevolge artikel vyf-en-sestig van die Doeane wet, No. 35 van 1944, met ingang van die datum van publikasie van hierdie kennisgewing, ondergenoemde opgeskorte regte waarvoor in die doeanaetarieff voorstiening gemaak is, in werking:—

KORTING VAN DOEANEREG.—WYSIGING VAN GOEWERMЕНTSKENNISGEWING No. 2069 VAN 8 DESEMBER 1944, SOOS GEWYSIG.

Hierby word vir algemene inligting bekendgemaak dat kragtens die bevoegdheid hom verleen by subartikel 2 (d) van artikel *ses-en-negentig* van die Doeane wet, No. 35 van 1944, die Minister van Finansies Deel IV van die Bylae by Goewermentskennisgewing No. 2069 van 8 Desember 1944, soos gewysig, hierby in die volgende opsigte wysig:—

(1) Deur in subparagraph (b) van subparagraph (36) van paragraaf 1 na die woord „gare” die woorde „ behalwe sajetgare ” in te voeg.

(2) Deur toevoeging tot paragraaf 1 van die volgende subparagraph:—

„(39) *Sigaarvervaardigingsnywerheid.* — Leë sigaardose van hout vir die verpakking van sigare in die Unie vervaardig.”

(3) Deur toevoeging van die volgende paragraaf:—

„2. 'n Korting van die doeane reg tot die bedrag vermeld word toegestaan op die volgende artikels, wat ingevoer of uit entrepot gelos word deur 'n vervaardiger vir verbruik in die onderskeie nywerhede hieronder genoem:—

(1) *Sigaarvervaardigingsnywerheid.* — Tabak, onbewerk, vir gebruik by die vervaardiging van sigare, per lb.: £0. 2s. 6d.”

OPMERKING.—Die uitwerking van hierdie kennisgewing is—

- (a) dat sajetgare nie meer onder korting van die intermediêre reg vir gebruik in die Tekstielnywerheid by die vervaardiging van gebreide goedere ingelaat mag word nie; en
- (b) om 'n korting van doeane reg tot die bedrag vermeld toe te staan op die ander genoemde artikels wat deur geregistreerde vervaardigers vir gebruik in die Sigaarvervaardigingsnywerheid vir genoemde doel ingevoer of uit entrepot gelos word.

DOEANEWET.—HERROEPING EN WYSIGING VAN SEKERE SPESIALE OPGESKORTE REGTE.

Ek, NICOLAAS CHRISTIAAN HAVENGA, Minister van Finansies, kragtens die bevoegdheid my verleen by artikel *vyf-en-sestig bis* van die Doeane wet, No. 35 van 1944, wysig hierby vanaf die datum van publikasie van hierdie kennisgewing, Goewermentskennisgewing No. 142 van 19 Januarie 1951, deur die spesiale opgeskorte reg voorgeskryf ten opsigte van paragraaf (d) (i) van item 76 en paragraaf (a) van item 80 te skrap en deur—

- (a) in tariefitem ex 65 (b) (iv) na die woord „uitsondering” die woorde „van die wat van sajetgare wat meer as 50 persent wol volgens gewig bevat gemaak is, en ” in te voeg;
- (b) in tariefitem ex 66 (c) na die woord „gemaak ” die woorde „, maar met uitsondering van sajetgare bevattende meer as 50 persent wol volgens gewig ” in te voeg;
- (c) in tariefitem 70 (a) na die woord „Sokkies ” die woorde „, met uitsondering van die wat van sajetgare wat meer as 50 persent wol volgens gewig bevat gemaak is ” in te voeg; en
- (d) in tariefitem 76 (b) na die woorde „(geweef of gebrei) ” die woorde „, maar met uitsondering van sajetstukgoedere (geweef) ” in te voeg.

REBATE OF CUSTOMS DUTY.—AMENDMENT OF GOVERNMENT NOTICE No. 2069 OF THE 8TH DECEMBER, 1944, AS AMENDED.

It is notified for general information that the Minister of Finance, in terms of the powers vested in him by sub-section 2 (d) of section *ninety-six* of the Customs Act, No. 35 of 1944, hereby amends Part IV of the Schedule to Government Notice No. 2069 of the 8th December, 1944, as amended, in the following respects:—

(1) By the insertion in subparagraph (b) of subparagraph (36) of paragraph 1 after the word „yarns ” of the words “other than worsted”.

(2) By the addition to paragraph 1 of the following subparagraph:—

“(39) *Cigar Manufacturing Industry.*—Empty wooden cigar boxes for packing cigars manufactured in the Union.”

(3) By the addition of the following paragraph:—

“2. A rebate of the duty to the extent stated shall be allowed on the following articles when imported or taken out of bond by a manufacturer for use in the respective industries specified hereunder:—

(1) *Cigar Manufacturing Industry.*—Unmanufactured tobacco, for use in the manufacture of cigars, per lb.: £0. 2s. 6d.”

NOTE.—The effect of this notice is—

- (a) that worsted yarns may no longer be admitted under Industry in the manufacture of knitted goods; and rebate of intermediate duty for use in the Textile
- (b) to provide for a rebate of duty to the extent stated on the other articles referred to when imported or taken out of bond by registered manufacturers for use in the Cigar Manufacturing Industry for the purposes stated.

CUSTOMS ACT.—WITHDRAWAL AND AMENDMENT OF CERTAIN SPECIAL SUSPENDED DUTIES.

I, NICOLAAS CHRISTIAAN HAVENGA, Minister of Finance, in terms of the powers vested in me by section *sixty-five bis* of the Customs Act, No. 35 of 1944, hereby amend as from the date of publication of this notice, Government Notice No. 142 of the 19th January, 1951, by deleting the special suspended duty prescribed in respect of paragraph (d) (i) of item 76 and paragraph (a) of item 80, and by—

- (a) inserting in tariff item ex 65 (b) (iv) after the word „excluding” the words “those made of worsted yard containing more than 50 per cent. by weight of wool, and ”;
- (b) inserting in tariff item ex 66 (c) after the word „shoddy” the words “, but excluding worsted yarns containing more than 50 per cent. by weight of wool.”;
- (c) inserting in tariff item 70 (a) after the word “socks ” the words “, excluding those made of worsted yarn containing more than 50 per cent. by weight of wool.”; and
- (d) inserting in tariff item 76 (b) after the words “(woven or knitted) ” the words “, but excluding worsted (woven) ”.
