MAXIMUM PRICES OF LUCERNE AND LUCERNE MEAL.

In terms of regulation 3 of War Measure No. 49 of 1946, I, Frederick Viljoen Ashpole, Price Controller, do hereby amend Government Notice No. 2702 of 21st November, 1952 (Maximum Prices of Lucerne and Lucerne Meal) by the substitution of paragraph 6 (1) hereof for the corresponding paragraph 6 (1) thereof:—

6. (1) Fix the maximum prices at which a manufacturer may sell lucerne meal to any person as follows:—

(a) If the lucerne meal is first grade lucerne meal made from baled lucerne, at 11s. 7d. per 100 lb. bagged;

(b) if the lucerne meal is second grade lucerne meal made from baled lucerne, at 10s. 10d. per 100 lb. bagged;

(c) if the lucerne meal is first grade lucerne meal made from loose lucerne, at 11s. 1d. per 100 lb. bagged; and

- (a) 'n gesonde karkas, teen 'n prys bereken ooreenkomsdig die tarief in genoemde Bylae gespesifiseer;

ten opsigte van daardie beheerde gebied vir 'n karkas van die klas of graad in daardie Bylae gespesifiseer, met betrekking tot die tydperk waarin die dier, waarvan die karkas afkomstig is, aldus ontvang word; met dien verstande dat indien 'n dier nie geslag word gedurende die week waarin dit ontvang word, soos voornoem, en die tarief vir die berekening van die prys gespesifiseer ten opsigte van die week waarin die dier geslag word, hoër is as die tarief gespesifiseer ten opsigte van die week waarin die dier aldus ontvang was, die Raad 'n prys sal betaal bereken teen die tarief gespesifiseer ten opsigte van die week waarin die dier geslag word, tensy die slag daarvan op aandrang of versoek van die eienaar van die dier of sy agent uitgestel was.

BEEF PRICES PAYABLE TO PRODUCERS IN CONTROLLED AREAS.

It is hereby notified that the Livestock and Meat Industries Control Board, constituted in terms of section 3 of the Livestock and Meat Control Scheme, published by Proclamation No. 265 of 1945, as amended, has in terms of section 14 of the said Scheme decided that it will, during the periods stated in the Schedule hereto, in any controlled area specified in the said Schedule, buy cattle carcasses, derived from cattle received at any abattoir in any such controlled area in accordance with the provisions of a permit issued by the Board, in the case of—

- (a) a sound carcase, at a price calculated in accordance with the rate specified in the said Schedule;
(b) a detained carcase, at a price calculated at a rate 10 per cent less than the rate specified in the said Schedule, in respect of that controlled area for a carcase of the class or grade specified in that Schedule,

in respect of the period during which the animal from which the carcase is derived, is so received; provided that if an animal is not slaughtered during the week in which it is received as aforesaid and the rate for calculating the price specified in respect of the week during which the animal is slaughtered, is higher than the rate specified in respect of the week during which the animal was so received, the Board will pay a price calculated at the rate specified in respect of the week during which the animal is slaughtered, unless the slaughtering was deferred at the instance or request of the owner of the animal or his agent.

For the purpose of the aforesaid decision any expression to which a meaning has been assigned in the Livestock and Meat Control Scheme, published by Proclamation No. 265 of 1945, as amended, shall have the meaning so thereto assigned; and—

“controlled area” means any area specified in Schedule I to Government Notice No. 2097 of 1950, which shall, in terms of a decision of the Board, be an area to which the provisions of this notice shall apply; “detained carcase” and “sound carcase” shall have the meaning thereto assigned in clause 1 of the Schedule to Government Notice No. 2100 of 1950.

Government Notice No. 88 of 9th January, 1953, is hereby repealed.
